High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

Subject to consents, BBV are due to have temporary traffic lights in place on the B4118 Birmingham Road. The traffic lights will be in place on an ad-hoc basis from the Monday 29 November until Friday 24 December. These works will include the creation of a site access, utility works and resurfacing of the carriageway. The temporary traffic lights will be in place from 9.30am – 3.30pm. BBV will keep you up to date with when the traffic lights are due to be in place through signage on the roadside.

HS2 during the COVID-19 pandemic

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. 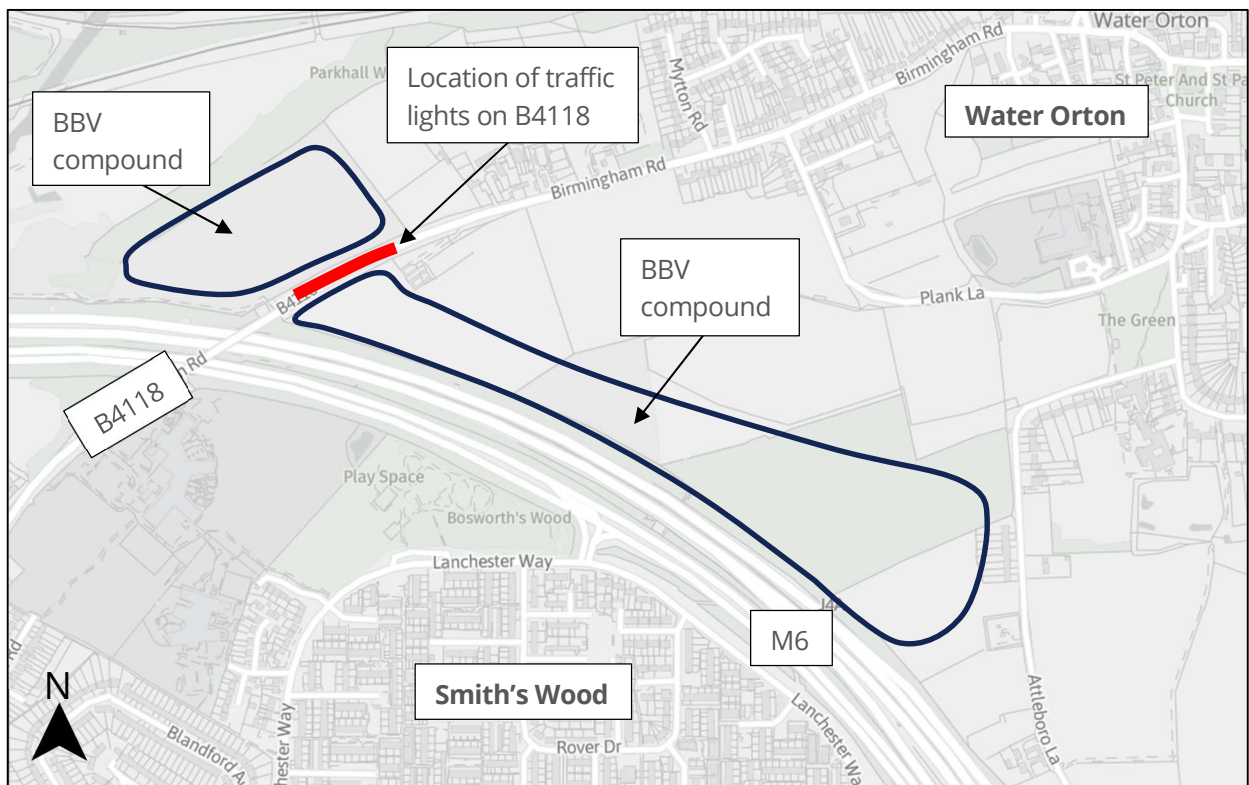
