High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

Installation of site access gate

We previously notified you that we will be installing a new site access gate at our site on Curzon Street. We originally told you that this work would take place on Wednesday 15 December. We however also now expect to need to continue with this work on Thursday 16 December.

Stop and go boards

To be able to complete this work safely, we will need to put in place manned stop and go boards along sections of Curzon Street. The stop and go boards will be operational from 9:30am to 3:30pm on both days. Access to properties and businesses will be maintained at all times.

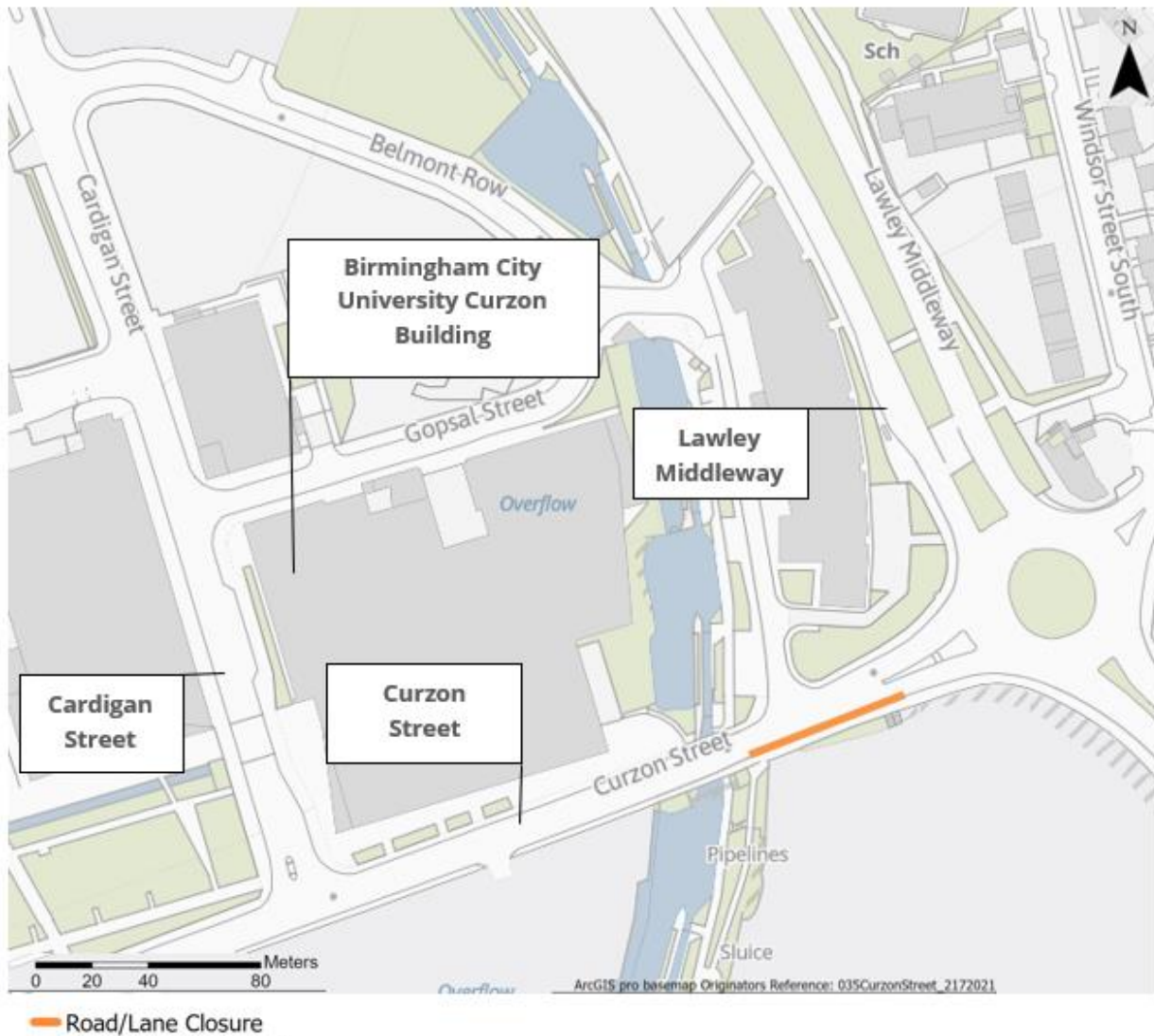
