



Temporary closure of Fradley and Streethay Public Right of Way 8

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we are doing

We will be temporarily closing the access to Public Right of Way, Fradley and Streethay 8. We will be completing surveys and vegetation clearance to help us understand more about the ground conditions where we are building the railway.

The Public Right of Way (PRoW) will be temporary closed with a fence barrier across it to protect the works area. A marshal will be present, who will give priority access to the PRoW users and will open the barrier to allow users to pass safely through the works area.

Public Right of Way Whittington 20 has been closed by Staffordshire County Council, and currently has no access from Fradley and Streethay 8 or Cappers Lane.

When will we undertake these works?

From December 13, 2021 until 17 December 2021.

The PRoW will have marshal in place Monday to Friday between the hours of 8:00am and 6:00pm.
