
Notice of temporary traffic lights on A445 Leicester Lane

High Speed Two (HS2) is the new high speed railway for Britain. Early work for HS2 is underway in your area, carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

Following LM's recent work on A445 Leicester Lane near Cubbington, we need to return to the same area for further roadside vegetation clearance. We are due to install temporary traffic lights on the road from **Wednesday 10 November to Saturday 13 November** to create a safe working zone. Our working hours will be between 9.30am and 3.30pm on weekdays and between 09.30am and 1.00pm on Saturday. Nearby, HS2's main construction contractor – Balfour Beatty VINCI – is due to close a section of Coventry Road from Monday 15 November to Thursday 2 December.
