Notice of CCTV drainage survey, A413, London Road

High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. As we increase face to face engagement, in addition to virtual engagement, we will ensure all events and meetings adhere to the guidelines. What are we doing?

We will be carrying out CCTV drainage surveys along a section of the A413 London Road. The surveys will provide us with information on the condition and location of the utility services and help us to decide how best to protect them while we are building HS2. These works will also enable us to understand the levels of silt within the system by using a small CCTV camera mounted on a small robot.

There will be temporary traffic management, in the form of a lane closure on the A413, London Road while we carry out these essential surveys.

We will also be completing vegetation and tree clearance works along a section of the A413 London Road.

Prior to any vegetation removal, an ecologist will complete a detailed survey of the area to be cleared. Any protected species found to be present will be recorded and the vegetation will be left undisturbed with the appropriate buffer zone established. Vegetation clearance will only commence once further surveys and mitigation can be established to confirm that the protected species are no longer present.

Due to reasons of safety and the proximity of the trees to the carriageway, there will be an overnight closure of the A413 London Road while we carry out the clearance and to minimise disruption during peak travel times.

9.00pm – 6.00am

Our contractors may be on site for one hour's start-up and shutdown either side of these times.

What to expect

Varied activities with both quiet and busier periods.

Overnight road closures and some additional traffic.

Daytime lane closure.

Noise from plant and equipment used for the works.

What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

Take care to respect the community.

CCTV Drainage Surveys

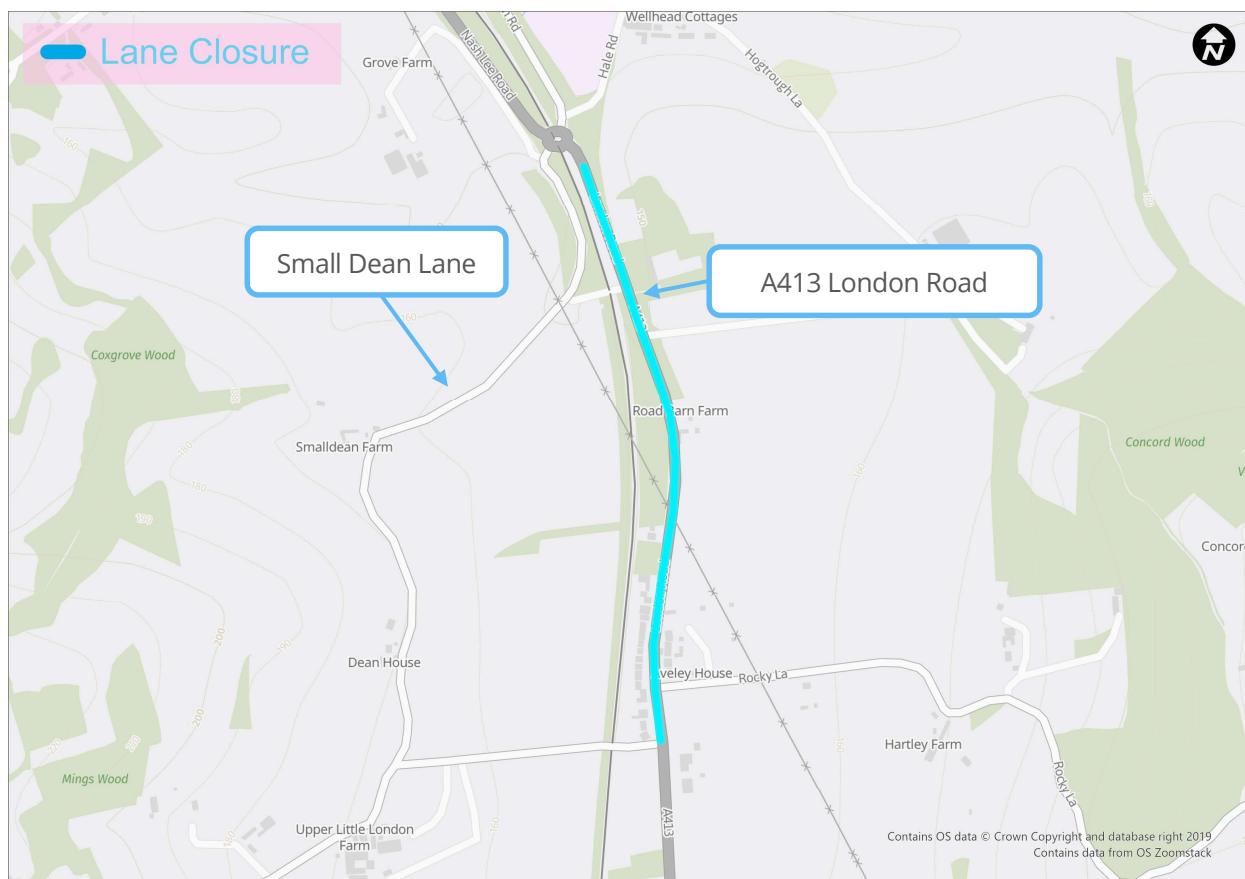
The A413 London Road will have temporary traffic management from 9.00am to 3.00pm from mid-December for three days, for the CCTV drainage works.

Vegetation Clearance

- The A413 London Road will be closed overnight, 9.00pm to 6.00am, from mid-December for three nights, to undertake the vegetation clearance.
