High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty Vinci is working on behalf of HS2 Ltd to build the new railway in your area.

Installation of temporary pedestrian ramp

We need to demolish and rebuild the existing Saltley Viaduct because it does not have enough room underneath for the new HS2 trains to pass through. Before we begin the construction of the new Saltley Viaduct we need to install a temporary ramp to create a safe crossing point for pedestrians and cyclists during our construction works.

What will we be doing?

To create the temporary pedestrian ramp, we will construct an earthwork ramp against the existing viaduct. We will begin constructing the temporary ramp in early December.

We will monitor and control the levels of noise, vibration and dust during our construction. Pedestrians, cyclists and vehicles will be able to continue to use Saltley Viaduct whilst we carry out these works.

December 2021 until March 2022.

Normal working hours
Monday to Friday 8am to 6pm. Saturday 8am to 1pm.
Our contractors will be on site for start-up and shut down for one hour either side of these times.

There may be occasional weekend working Saturday 8am 1pm subject to local authority consent.

Clear pedestrian signage in place.

Construction machinery digging and moving earth.

Workers in high vis.

Ensure all work areas are safe and secure.

Monitor and control the levels of noise, vibrations and dust during our operations.
