



Notice of traffic management – Coleshill Heath Road (revised date)

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be completing

We had previously sent out a notification outlining construction works for the access to Heath Park on Coleshill Heath Road, this work was due to be completed by 21 January 2022. As a result of our reduced working window, brought into ease traffic flows and minimise disruption, it will be necessary to continue the works longer than expected.

The works will now continue until 4 February. We will have traffic lights in place throughout these works as shown overleaf.

It may be necessary for Saturday working dependant on the progress, if it is necessary our working hours for Saturdays will be 8.00am until 1.00pm, our working hours Monday to Friday will be 9.30am until 4.00pm. Pedestrian access will be maintained at all times and the bus stop has been relocated outside the lane closure.

COVID-19

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

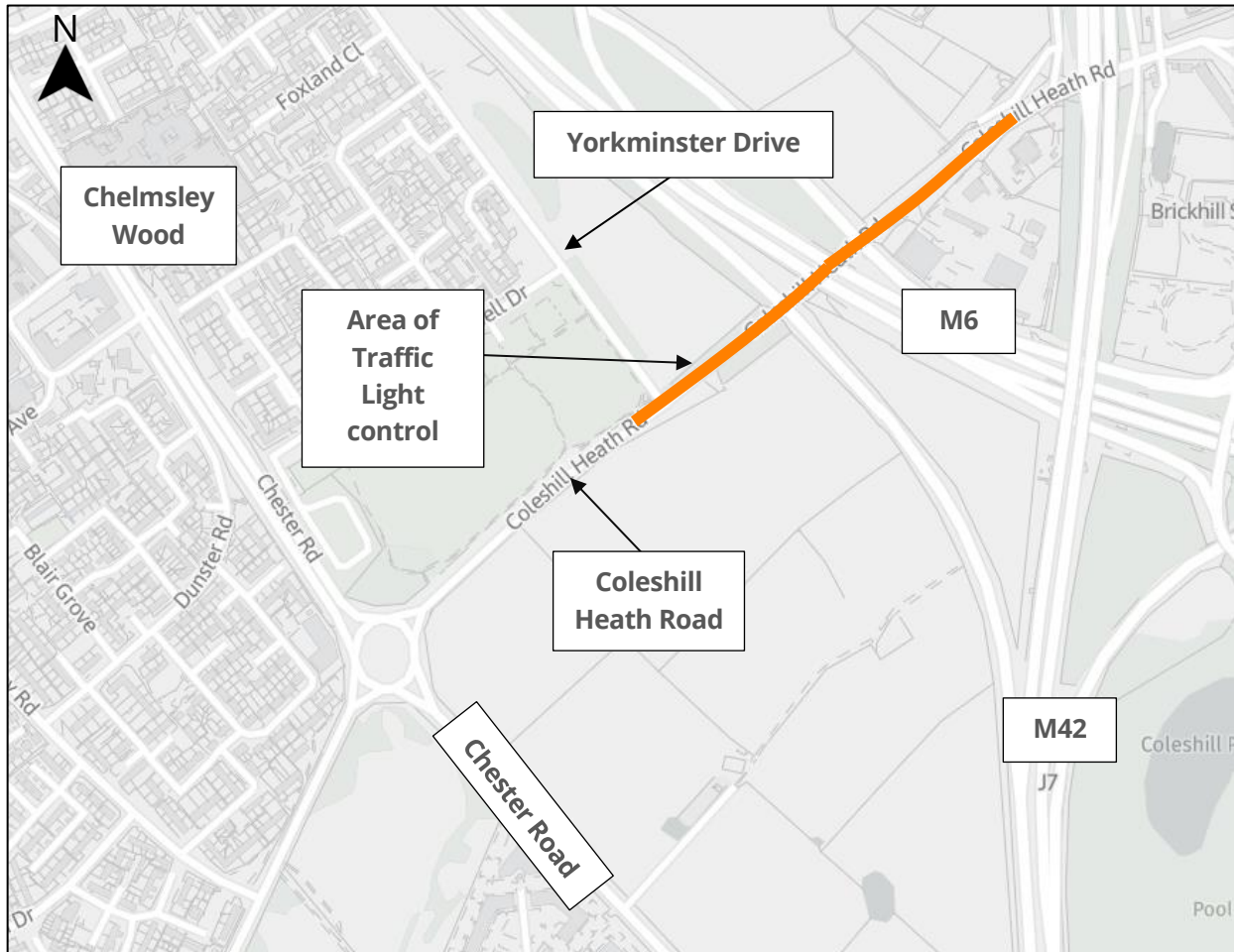
