



Notice of traffic management A452 Kenilworth Road

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work will we be doing

BBV will be carrying out trial hole excavations and surveys in the existing verge, carriageway and central reserve of the A452 from Meriden Roundabout to the Aston Martin roundabout on the south bound and north bound carriageways. This is to locate and identify existing utility services.

When these works will take place

To carry out these works safely, we will install a temporary lane closure to access these areas.

Works are scheduled from Monday 6 December to Monday 20 December and will be in place 24/7. These works are subject to weather conditions.

- Slight increase in journey time on Kenilworth Road


