High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

From Monday 17 January 2022, we will be completing pavement coring and survey works. For us to carry out these works safely, we will put in place a full closure on Lavender Hall Lane. The closure will be in place from 9.30am until 3.30pm between Monday 17 January 2022 and Friday 21 January 2022. A fully signed diversion will be in place during these times.

Whilst we are carrying out these works, early works contractor, Laing O'Rourke, and Murphy & Sons, known as LM will be removing roadside vegetation at the same time.

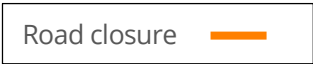
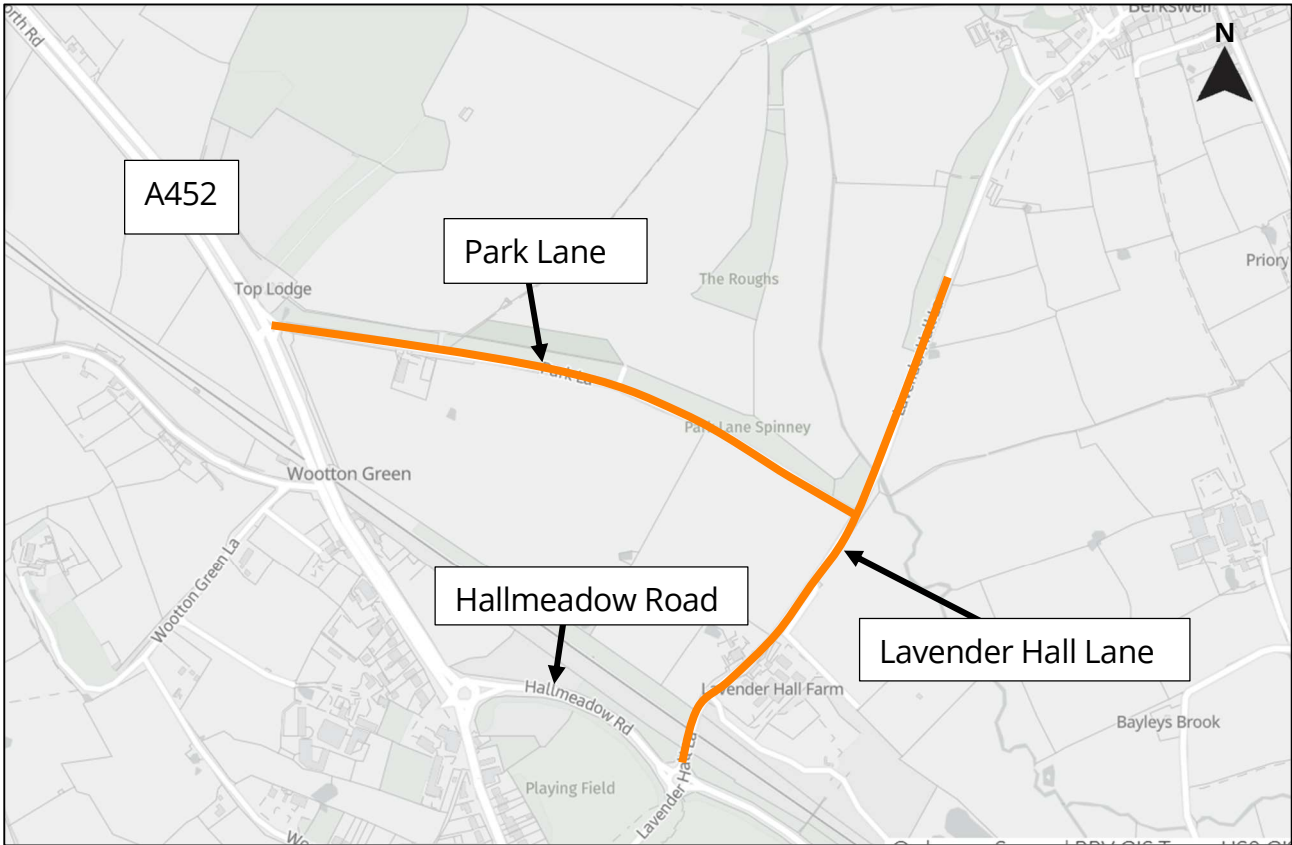

The location of the closure on Lavender Hall Lane is shown in orange on the map below.

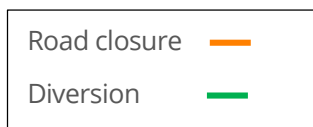
