High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work will we be doing

From Tuesday 4 January 2022 to Friday 14 January 2022, we will be carrying out trial hole excavations in the verge of the B4102 Meriden Road near to Patrick Farm to identify existing utility services. To carry out these works safely, we will install temporary traffic lights on Meriden Road. The traffic lights will be operational from 09.30am to 3.30pm.

- Our workforce may be on site one hour before and after to set up and take down our work equipment

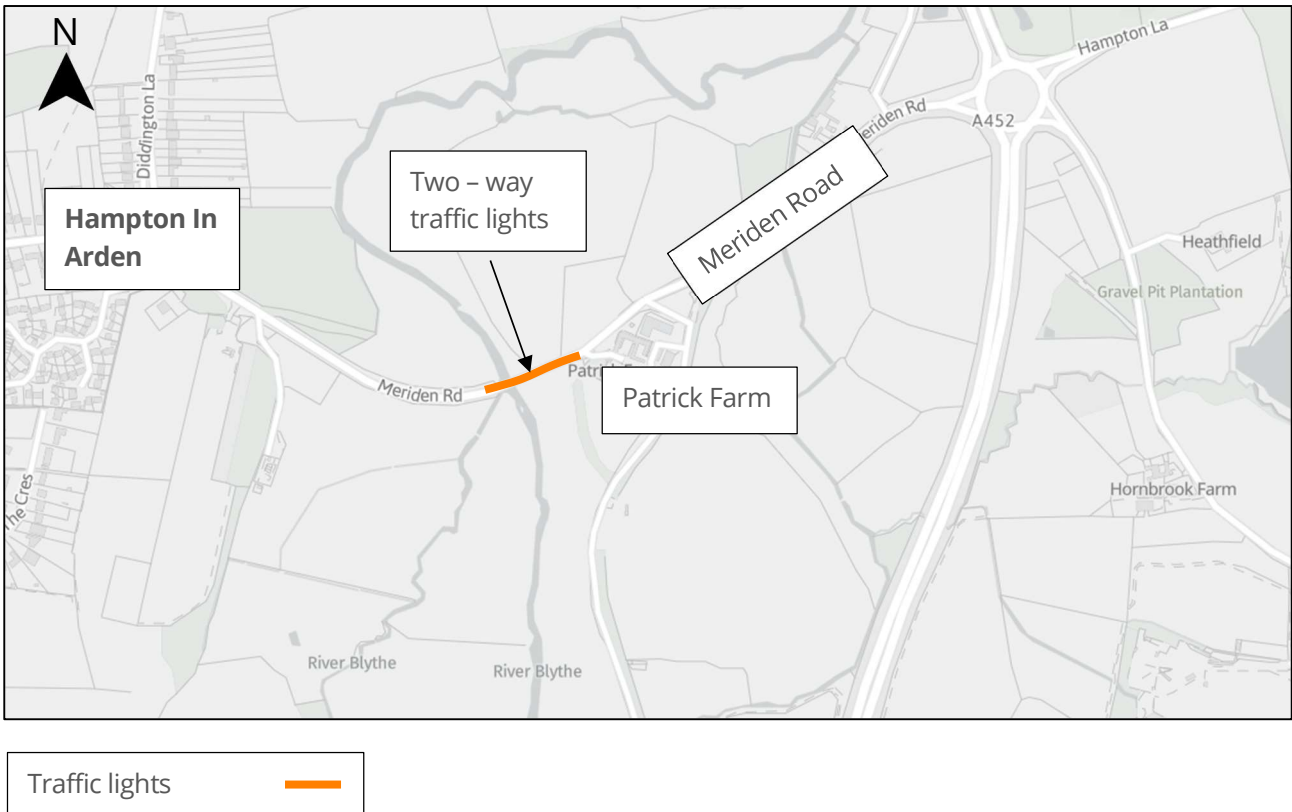
