Notice of traffic management – Coleshill Heath Road (revised date)

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be completing

We had previously sent out a notification outlining trial excavation works to be complete on Coleshill Heath Road. Our works initially were set to take place from Monday 20 December until Wednesday 22 December. As a result of our reduced working window, brought in to ease traffic flows and minimise disruption, we will continue works for longer than expected. Firstly, prior to Christmas we will extend our works from Wednesday 22 December until Thursday 23 December.

After Christmas we will continue works from Monday 10 January until Friday 21 January. We will have traffic management throughout both these sets of work. **The traffic management location is outlined overleaf.**

There may be Saturday work dependant on the programmes progress, our working hours for Saturdays are 8.00am until 1.00pm and our working hours will be 9.30am until 4.00pm weekdays. The pedestrian access will be maintained at all times and the bus stop has been relocated outside the lane closure.

COVID-19

We are continually reviewing the works on our construction sites in line with the Government and Public Heath England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is out key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.


