



## Notice of single lane closure on Faraday Avenue / Hams Lane

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

### What work will be taking place

We will be undertaking works to create an entrance to our working area off Faraday Avenue. The entrance will allow our vehicles to safely access our working areas and receive deliveries of materials and equipment for the construction of the HS2 line. To complete these works safely, we will install a single lane closure on the outbound carriageway on Faraday Avenue during this period. We also need to undertake surveys on Hams Lane (see map on page 2).

### Duration of the works

The two-day single lane closure on Hams Lane will take place on Monday 10 January and Tuesday 11 January 2022, between 9.30am to 3.30pm.

The single lane closure on Faraday Avenue will begin on Monday 17 January and will continue to Friday 28 January. We will undertake these works between Monday and Friday each week and our working hours will be 9.00am to 5.00pm. Our workforce will be on site one hour before and one hour after to set up and take down equipment.

### HS2 during the COVID-19 pandemic

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

### Duration of works

The two-day single lane closure on Hams Lane will take place on Monday 10 January and Tuesday 11 January 2022, between 9.30am to 3.30pm.

The Faraday Avenue single lane closure will take place between Monday 17 January to Friday 28 January 2022. Our working hours will be 9.00am to 5.00pm (Mon-Fri).

Our workforce may be on site one hour before and after to set up and take down our work equipment.

### What to expect

A single lane closure will be in operation during this period.

Some low-level noise will be generated from the work we are completing.

### What we will do

Keep all sites safe and secure.
