High Speed Two (HS2) is the new high speed railway for Britain.

Gower Street Slip Lane – Tuesday 23 November (Night Works)

From 9pm Tuesday 23 November until 5am Wednesday 24 November 2021, CSjv will be carrying out Anti-Skid resurfacing works on the Gower Street Slip Lane with Euston Road. During these works a full road closure will be required with a diversion route via Tottenham Court Road and University Street.

Gordon Street – Wednesday 24 November 2021 (Night Works)

From 1am until 5am on Wednesday 24 November, CSjv will be carrying out Anti-Skid resurfacing works on Gordon Street. The works will begin in the southbound lane, once complete the work site will be moved to the northbound lane. During these works a full road closure will be required with a diversionary route via Woburn Place, Great Russell Street, Bloomsbury Street and Gower Street

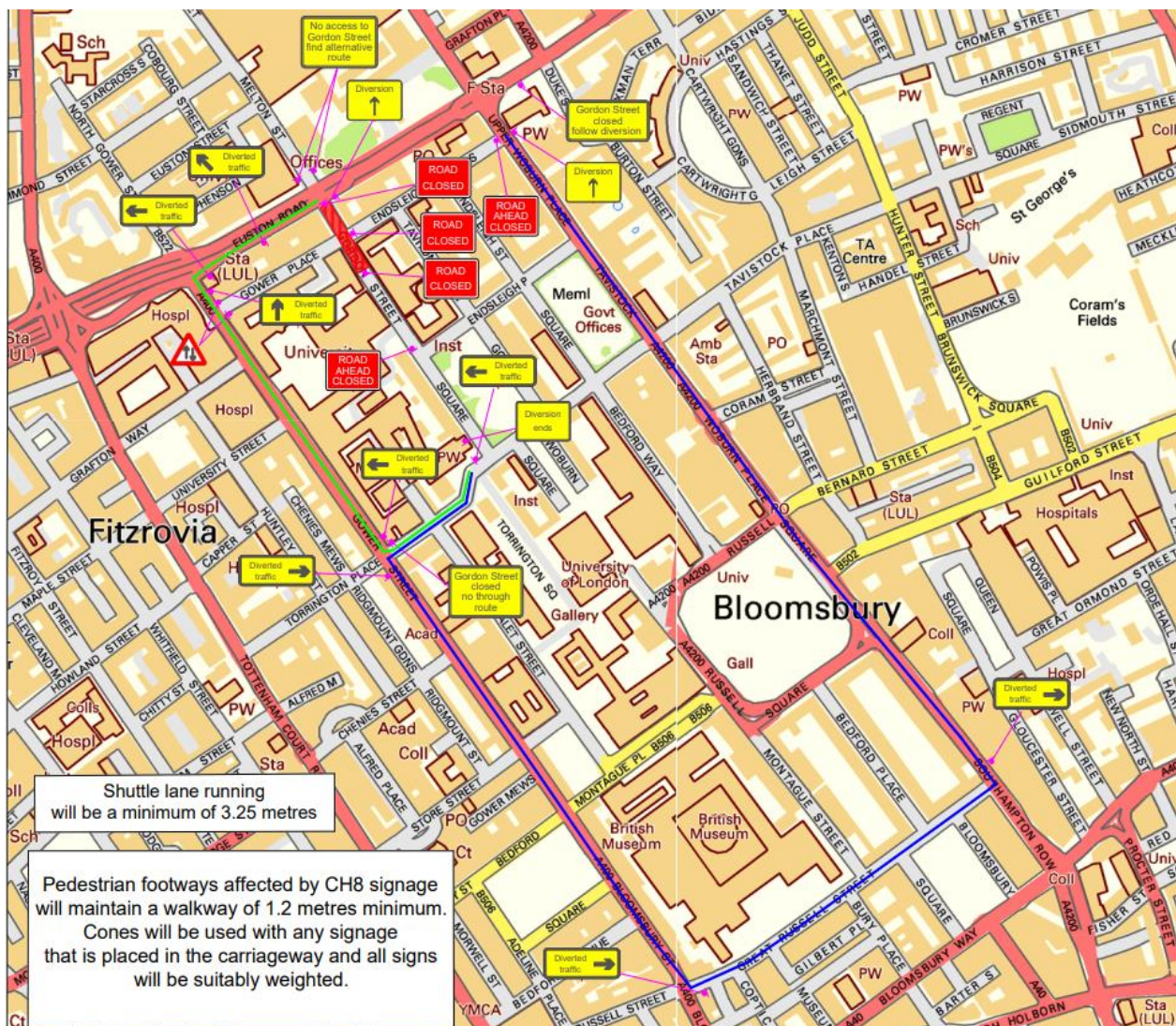
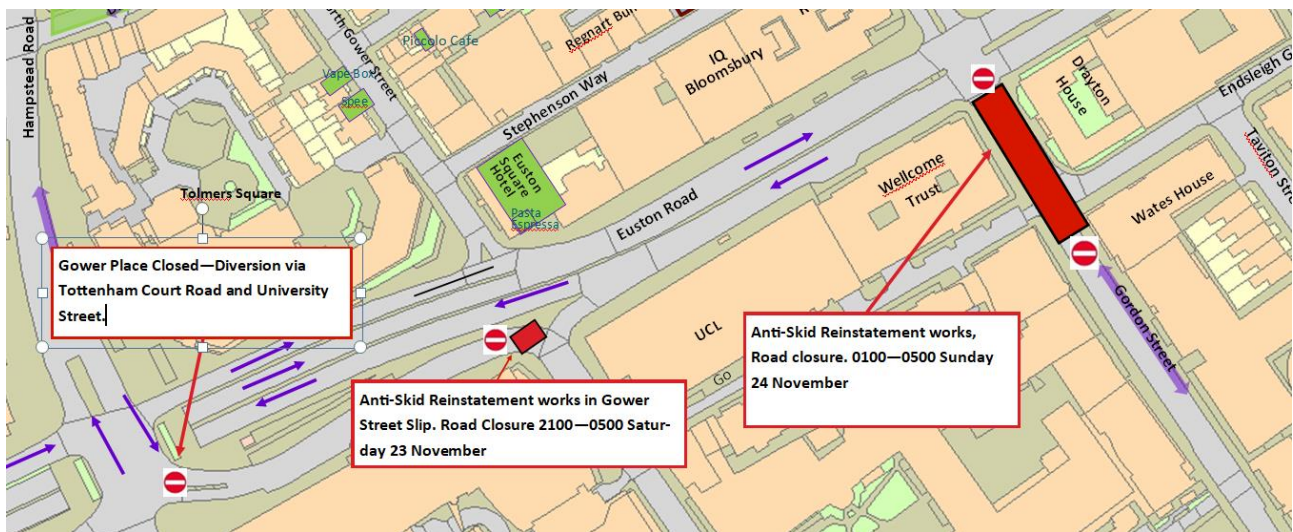
A full road closure of Gordon Street and Gower Street Slip with Euston Road.
