We are following Government and Public Health England (PHE) advice on working safely during the pandemic. As we increase face to face engagement, in addition to virtual engagement, we will ensure all events and meetings adhere to the guidelines. ## What we are doing

We wrote to you in May 2021 to let you know that we would be undertaking CCTV surveys of utilities on Oldfield Lane North, Greenford. We now require an additional visit to assess these works.

From 7 December from 10pm to 6am on 8 December 2021, we will be carrying out utility surveys on the junction of Oldfield Lane North and Rockware Avenue, Greenford, in the area shown on the map overleaf. These surveys will provide us with information on the condition of the utility services and help us to decide how best to protect them while we are building HS2.

We will investigate the condition of the sewer system using a CCTV camera, accessing the sewer through the access hatch in the road.

## How the surveys might affect you

Temporary traffic management will be in place to ensure the surveys can be carried out safely.

Your utility services will not be affected.

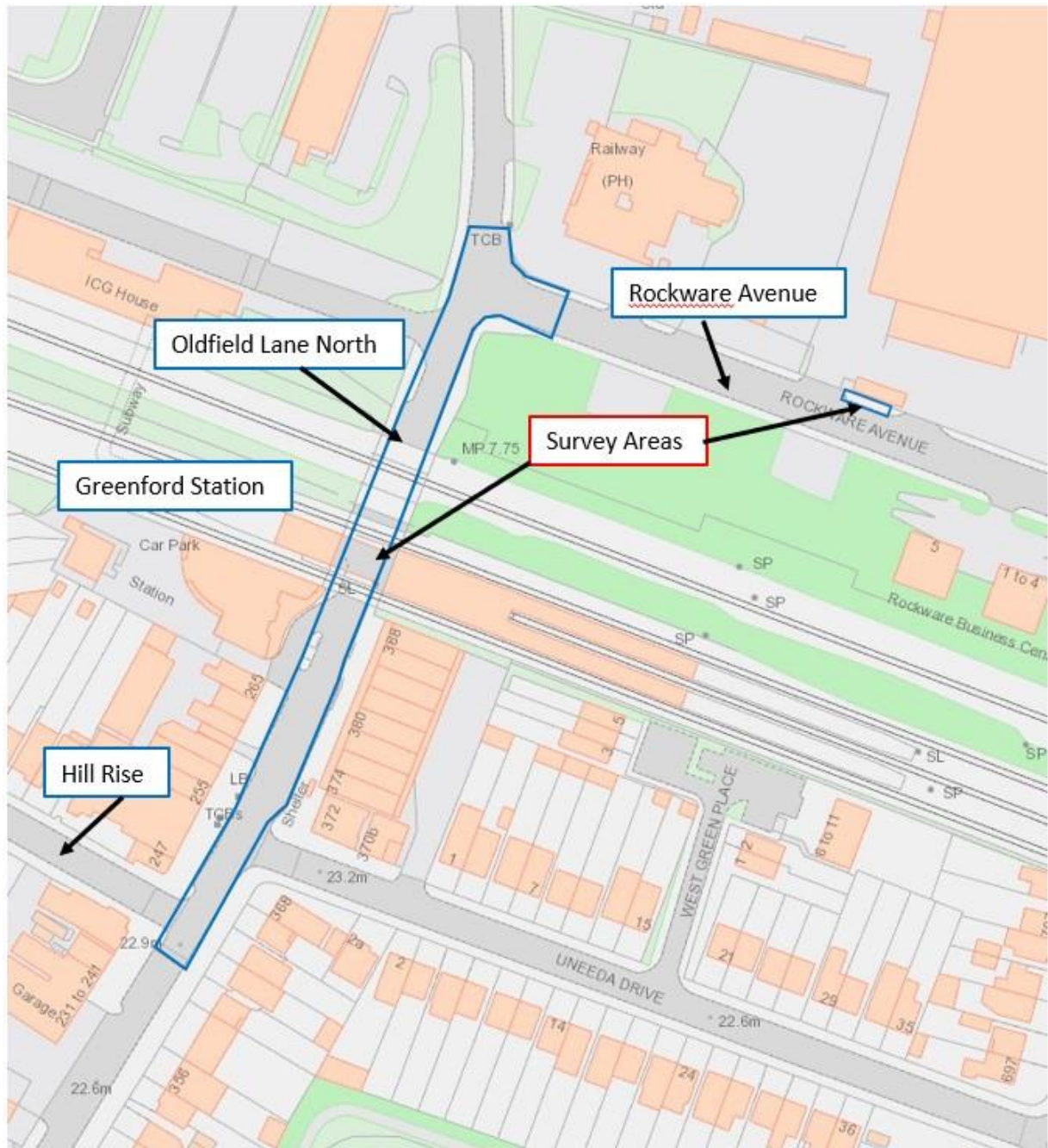
