Update on sheet piling at Mandeville Road site

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. You can sign up for regular updates in your local area at hs2inkilburnandnortholt.co.uk.

Sheet piling

We wrote to you in October to inform you of the upcoming sheet piling and hoarding removal at the northern end of our site. This date has now been rescheduled to start in December.

Due to the supporting concrete blocks being in close proximity to these works, we will need to remove a small section of the existing hoarding, adjacent to the Carr Road access track.

We will replace that section of hoarding with heras fencing with a noise reducing cover to help manage the noise from site. This hoarding will be removed **from 6 to 9 December** to allow us to survey the ground for high voltage cabling in advance of sheet piling. The hoarding will be reinstated by **28 January 2022**.

From 4 to 28 January 2022, we will be installing sheet piling close to the boundary of the northern end of our site, as shown on the map below.

How these works might affect you

You may notice periods of increased noise during these works due to the reduced height in the fencing along the site boundary.

We would like to apologise in advance for any disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way. We will ensure that disruption is kept to a minimum.

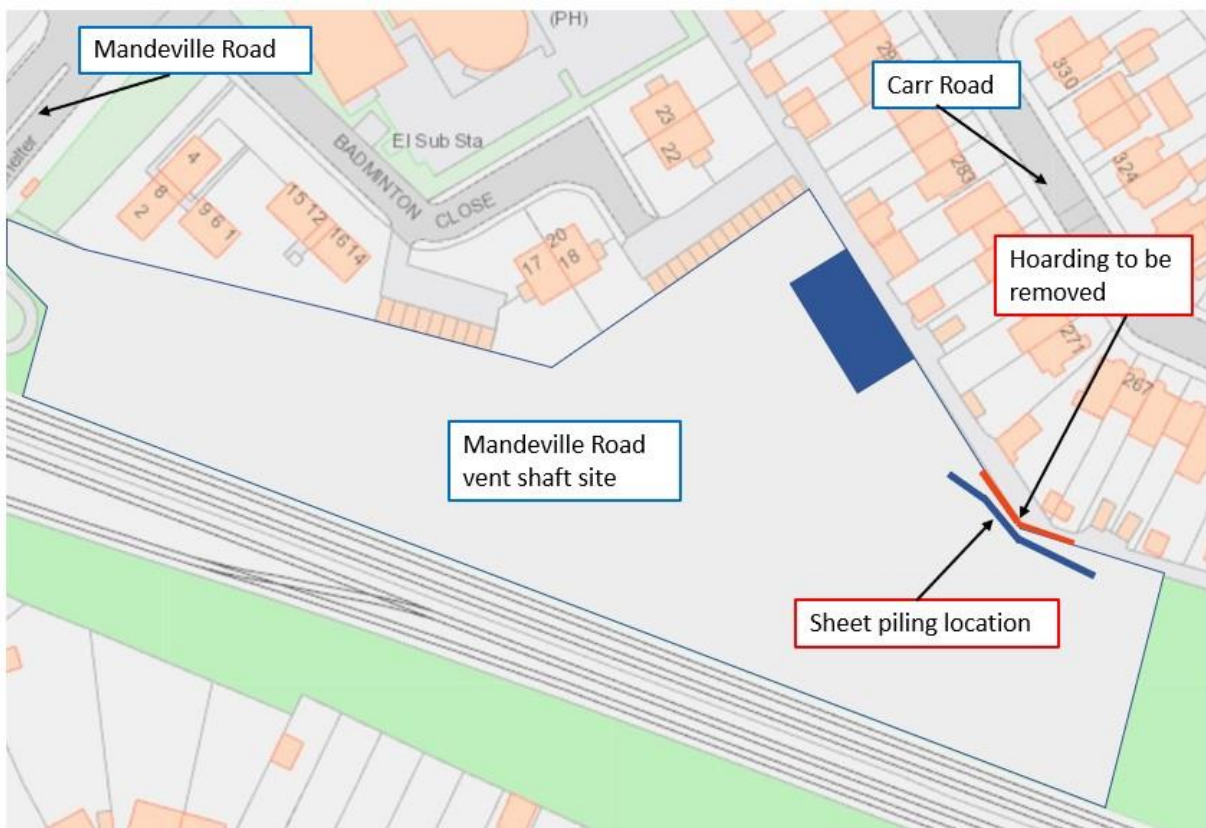
