

# Notice of works planned on Greenpark Way Road

High Speed Two (HS2) is the new high speed railway for Britain.

## Works planned on 26 December 2021

On 26 December 2021, we will be installing a bridge on Greenpark Way Road near the Royal Mail distribution centre. The bridge is being installed to allow us to safely carry over dewatering pipes from our site into the Grand Union Canal.

The installation will take approximately four hours to complete, and we will use a 200-tonne crane to lift the bridge into place. A road closure will be in place from 10am to 2pm on Greenpark Way Road.
