



## Notice of traffic management: A429 between Coventry and Kenilworth

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the high-speed railway in your area.

### The work we will be doing

In preparation for future works BBV will be carrying out surveys in the existing road and drainage systems on a section of the A429 Kenilworth Road. This is to identify existing utility services and carry out Ground Investigation (GI) surveys. GI is the examination and study of the soil, rocks, and groundwater below the surface. A number of methods are used to obtain samples and to monitor and test them. For example, boreholes may be dug by hand around utility pipelines or by using a rig in more open areas. To complete this work safely we need to install a lane closure controlled by temporary traffic lights. (See map over).

### When this work is taking place

A lane closure controlled by temporary traffic lights will be in place from 17 January 2022 to 29 January 2022 between 9.30am and 3.30pm Monday to Friday and between 9.30am and 1.30pm on Saturday. Our workforce may be onsite one hour before and one hour after these times to set up and secure our equipment.

### HS2 and the Coronavirus

The Government's current Coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. A lane closure controlled by traffic lights will be in place from 17 January 2022 to 29 January 2022. 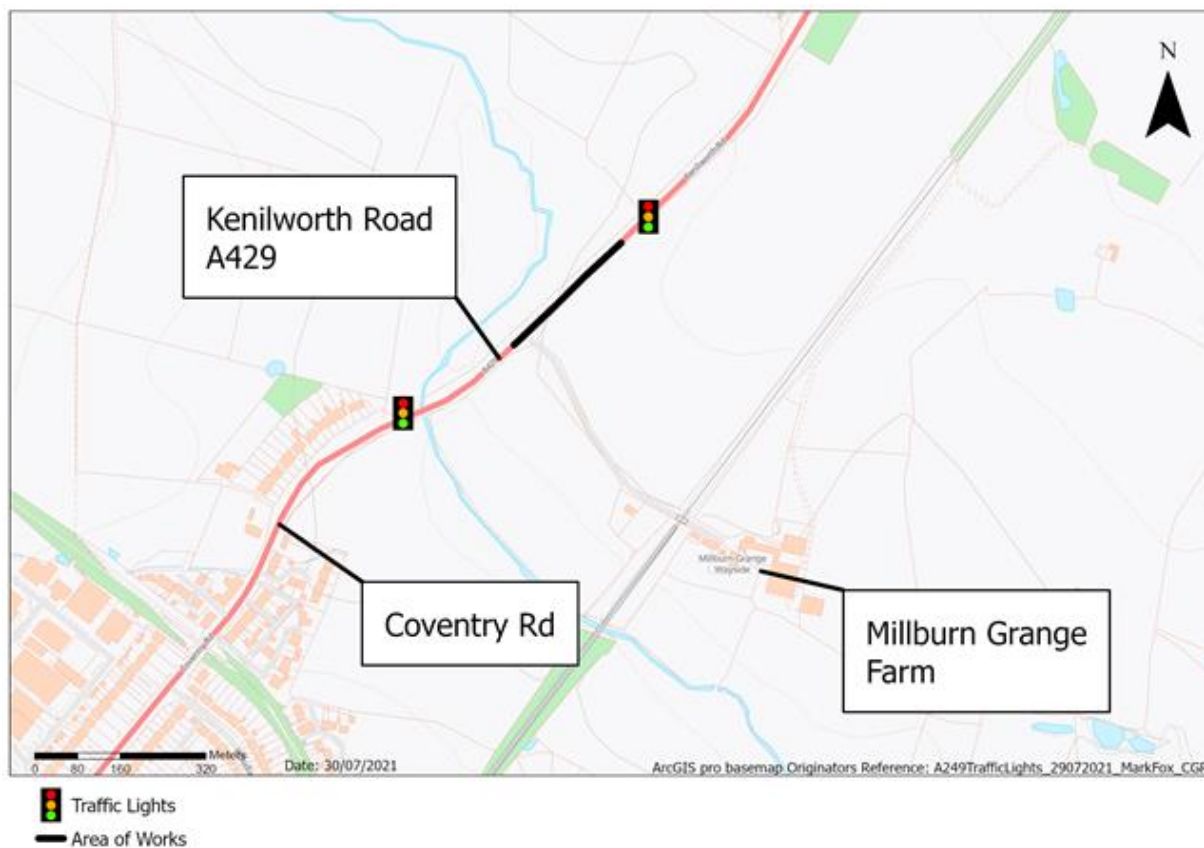
