
High Speed Two (HS2) is the new high speed railway for Britain.

Varndell Street - Saturday 18 December (1 Day Only)

From 8am Saturday 18 December until 1pm Saturday 18 December 2021, CSjv will be carrying out Anti-Skid resurfacing works on Varndell Street. Installation of the surface is expected to only take a few hours. During these works a full road closure of Varndell Street will be required with a diversion route via Robert Street and Stanhope Street.
