



## Notice of temporary road closure update, Mixbury

High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. As we increase face to face engagement, in addition to virtual engagement, we will ensure all events and meetings adhere to the guidelines. ### What are we doing?

As part of our continued preparatory works for our internal haul and access roads we will need to close Featherbed Lane, also known as Fulwell Lane for approximately two weeks. The closure will be during the day, from 8.00am to 6.00pm, with a local diversion route in place.

These works will involve the completion of the internal haul road and construction of a passing bay that will be needed to operate the crossing.

As the preparatory works will require large plant and machinery and time for concrete to set, we are required to close these sections of road during the day. This is for the safety of road users and our staff.

In early Spring, Featherbed Lane will also be closed for asphaltting works. We will continue to update the community when further information becomes available.

### When will these works take place?

Featherbed Lane, also known as Fulwell Lane, will be closed from 8.00am to 6.00pm, Monday 24 January to Friday 4 February, with a local diversion in place.

We will work to open the roads to reduce disruption as soon as possible.

Saturdays

8.00am – 1.00pm

Our contractors may be on site for one hour's start-up and shutdown either side of these times.

Varied activities with both quiet and busier periods.

Road closures and some additional traffic.

Noise from plant and equipment used for the works.

### What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

Take care to respect the community.

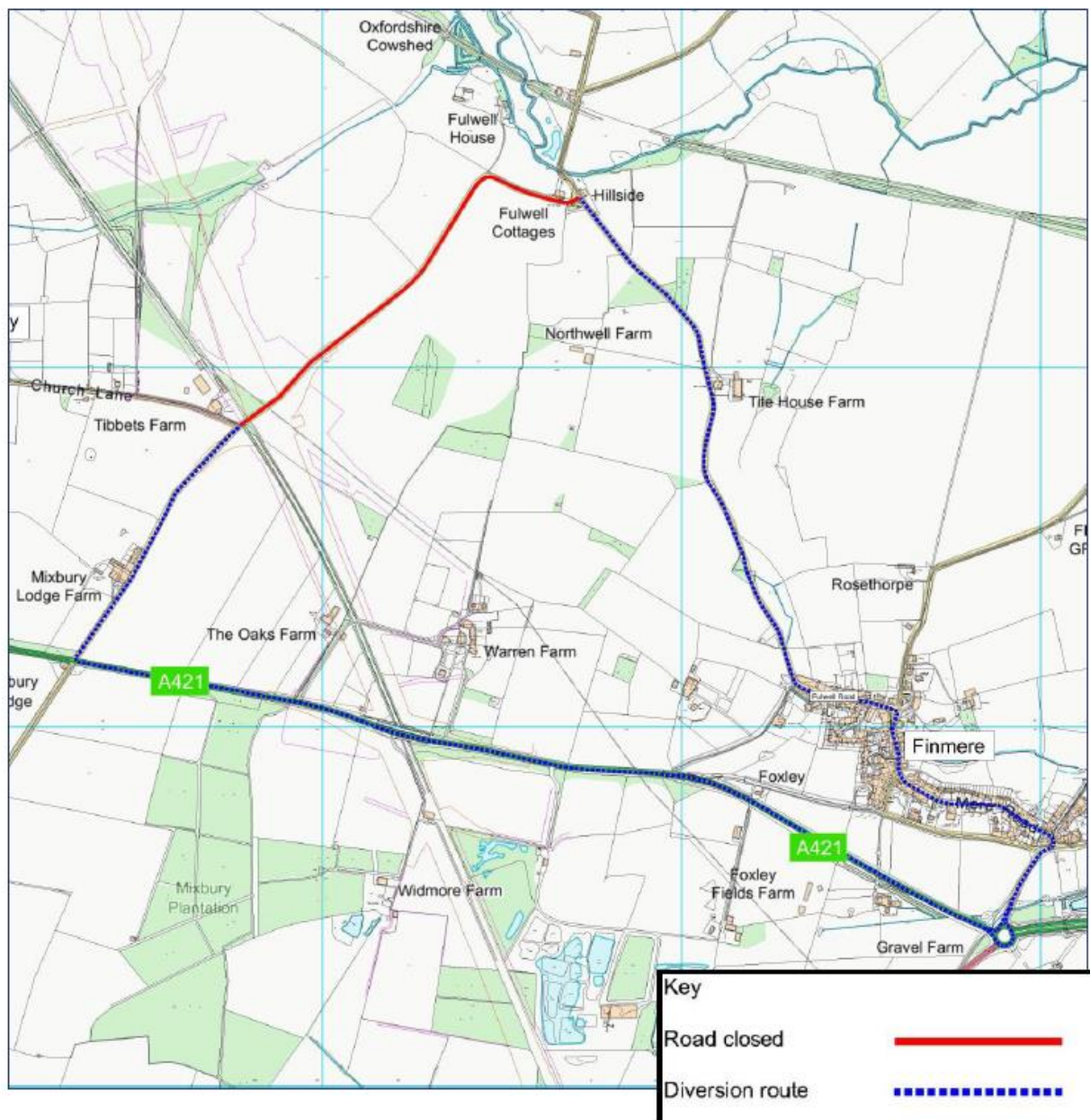

## Where will the works take place?

The map below, shows the closure on Featherbed Lane, also known as Fulwell Lane, and the local diversion through Finmere Village.

Once the crossing point is created, the roads will then be reopened, with gates in place to keep local traffic separated from construction traffic. All plant crossings, without exception, will be signal controlled.
