High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. ### What are we doing?

Further to our last notification in February 2021 when we wrote to inform you about the significant programme of tree planting that would take place in the Jones Hill Wood area up until Spring 2021.

We are now updating to let you know that we will be undertaking further planting in Jones Hill Wood in January 2022. This work is part of our winter planting programme and will see a further 2500 trees planted in the area.

The site for the tree planting works is located between Bowood Lane and Kings Lane and will include native species such as Rowan, Birch and Guelder-rose.

The workforce and deliveries will access via Bowood Lane and will be located at the existing compound at Durham Farm.

Work will be completed by February 2022.
