



# Update: notice of ground investigation survey work near Bar Hill Road

High Speed Two (HS2) is the new high speed railway for Britain. Working on behalf of HS2 Ltd, Balfour Beatty is carrying out surveys and investigating ground conditions along the Phase 2a route.

## What we are doing

We're carrying out ground investigation work to help us better understand the ground conditions along the route. This will help to inform the detailed design of the railway. To do this, we will use techniques including the drilling of boreholes and trial pits. We are carrying out this work near Bar Hill Road. To carry out the work, we will use some heavy goods vehicles as well as light goods vehicles, such as tractors and telehandlers.

## Covid-19

We are working in line with Government and Public Health England (PHE) advice on working safely during the pandemic. For all events and engagement, we will carry out a risk assessment and put in place control measures to manage the risk of Covid-19 to the public and our staff. ## How we will reduce disruption

We will keep construction traffic to a minimum, wherever possible. To reduce impact on your journeys, we will avoid travelling at peak times during the day. We will also keep our sites secure at all times.

- The works are due to start in early December 2021 and are expected to last until early January 2022.

## What to expect

- Slightly more traffic than usual on Bar Hill Road for the duration of works.
- Temporary traffic lights on Bar Hill Road 6 to 21 December 2021, then 5 January 2022 for the duration
- Possible visual and sound impact on your property
- Working hours Monday to Friday 8am to 6pm

## What we will do

- Carry out the work in compliance with the Code of Construction Practice
- Inform you in advance of any changes to the dates and working times shown
- Keep all sites safe and secure
