



Notice of traffic management: Blind Lane and Cryfield Grange Road

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We need to carry out Ground-penetrating radar (GPR) surveys on Blind Lane and Cryfield Grange Road. GPR uses radar pulses to create a profile of what the ground looks like beneath the surface. GPR can be used in a variety of ground conditions, including rock, soil, pavements, and structures. The GPR can be pushed along by hand, attached to a buggy or – on a larger scale – can be attached to a van or tractor. To complete these surveys safely we need to temporarily close these roads.

When these works will take place

- **Blind Lane** will be closed on **7 January 2022**
- **Cryfield Grange Road** will be closed on **10 January 2022**

Both closures will be in place between 8am and 6pm, our workforce may be on site one hour before and one hour after to set up and secure our equipment. Access to all properties and will be maintained during these closures. Fully signed diversions will be in place.

HS2 and the COVID-19 outbreak

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance. 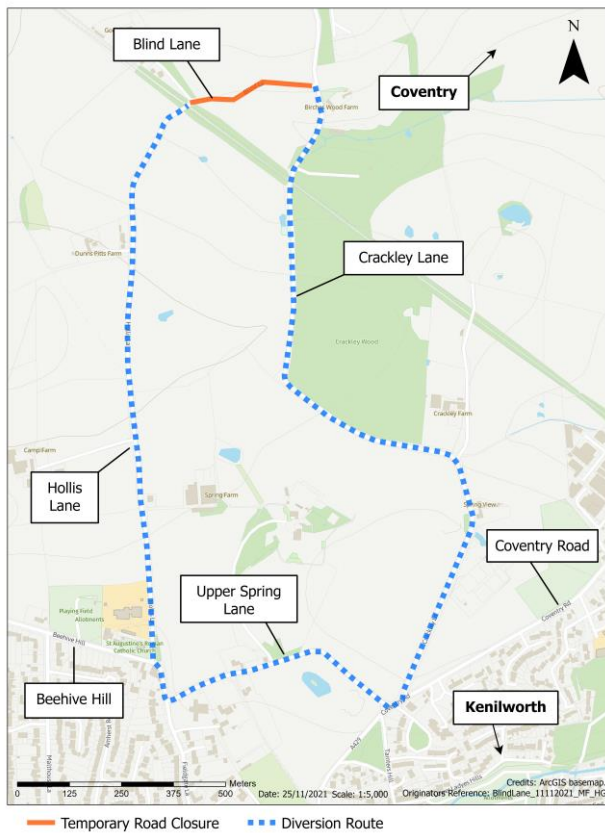
- A fully signed diversion
