High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We are working on piling works near Cromwell Lane bridge to enable construction of the cut and cover bridge and other activities. Piling is a type of deep foundation that will support future structures. To complete this work safely we need to divert pedestrians from the North pavement onto the South pavement. The South pavement will remain open with two clearly marked crossing points either side of the closure. **Cromwell Lane will remain open for vehicles under temporary traffic light control during this work.**

When these works will take place

As we prepare to build the cut and cover tunnel near Cromwell Lane bridge, a full-time pedestrian diversion is required to be in place from **4 January 2022** for approximately 24 months.

HS2 and the Coronavirus

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with Coronavirus. The Government's current Coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Duration of works

A pedestrian diversion will be in place from **4 January 2022** for approximately 24 months.

Our normal working hours are 8am to 6pm Monday to Friday and 8am to 1pm on Saturday.

Our workforce can be on site one hour before and one hour after to set up and secure our site.

What to expect

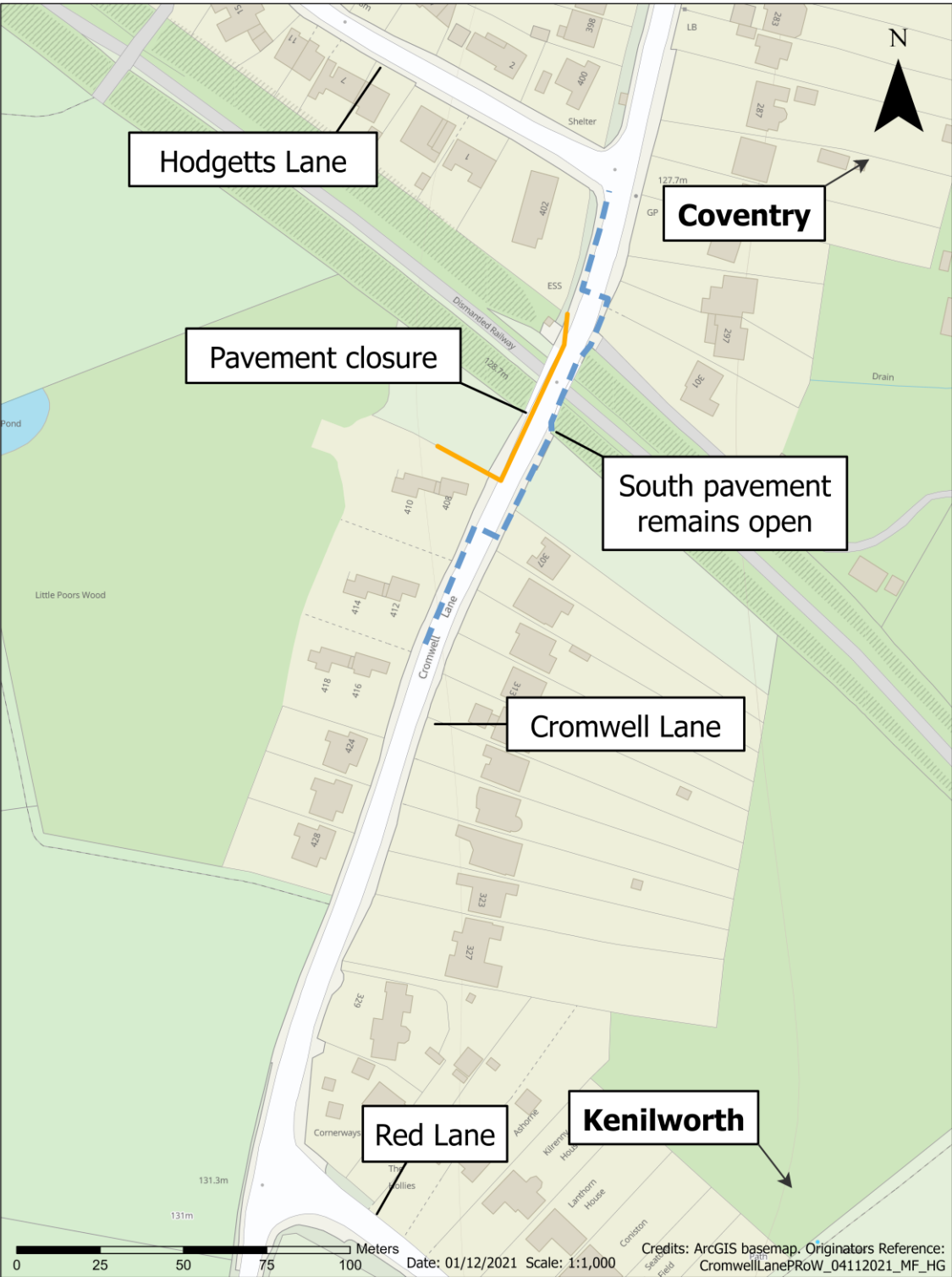
- North pavement on Cromwell Lane bridge closed to pedestrians
- South pavement on Cromwell Lane bridge open to pedestrians
- Two clearly marked pedestrian crossing points either side of the pavement closure
- Driver access along Cromwell Lane is unaffected.
