## **Upcoming traffic management Cromwell Lane, Burton Green**

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

#### The work we will be doing

To allow us to work on the Burton Green tunnel we need to install temporary traffic management on Cromwell Lane. This management will be in the form of a single day road closure and a longer period of temporary traffic lights.

- The road will be closed with a fully signed diversion in place between 8am and 6pm on **4 January 2022**
- On 5 January 2022 we will install temporary traffic lights these will remain in place for approximately 24 Months. These lights are essential to allow us to complete our work safely.
