Old Oak Common Lane temporary footway closure

On Wednesday 15 December 2021, we will be installing monitoring equipment onto the façade of Kildun Court. To do this, we will need to erect an access platform on the western footway on Old Oak Common Lane, in front of Kildun Court. This footway will need to be closed during the works, from 8am to 5pm. Pedestrians will be diverted to the eastern footway during the closure, and signage will be in place to advise pedestrians of these changes. The temporary bus stop in this location will be relocated by TfL.

Duration of works

Section of the western footway of Old Oak Common Lane closed from 8am to 5pm on Wednesday 15 December 2021.

What to expect

Pedestrians will be diverted to the eastern side of Old Oak Common Lane. An access platform will be erected in front of Kildun Court, and workers will be installing monitoring equipment onto the Kildun Court building.
