



# Notice of road closure St James Place and Viaduct Street

High Speed Two (HS2) is the new high speed railway for Britain. Is working in partnership with HS2 Ltd to build the new railway in your area.

## Road Closure

Ahead of constructing the viaduct which will carry the new HS2 line we will need to close a section of St James Place and Viaduct Street to both vehicles and pedestrians. The closure will be in place until we complete construction works in mid-2024.

## Installation of fencing

To close the road, we will be installing fencing along a section of St James Place and Viaduct Street. We need to install this fencing to create a safe segregated space to start constructing the new viaduct that will be located in the area.

We will start installing the fencing on Tuesday 4 January and expect to complete the installation by Tuesday 11 January. As we install the fencing you may notice workers in hi-vis and construction vehicles carrying materials.

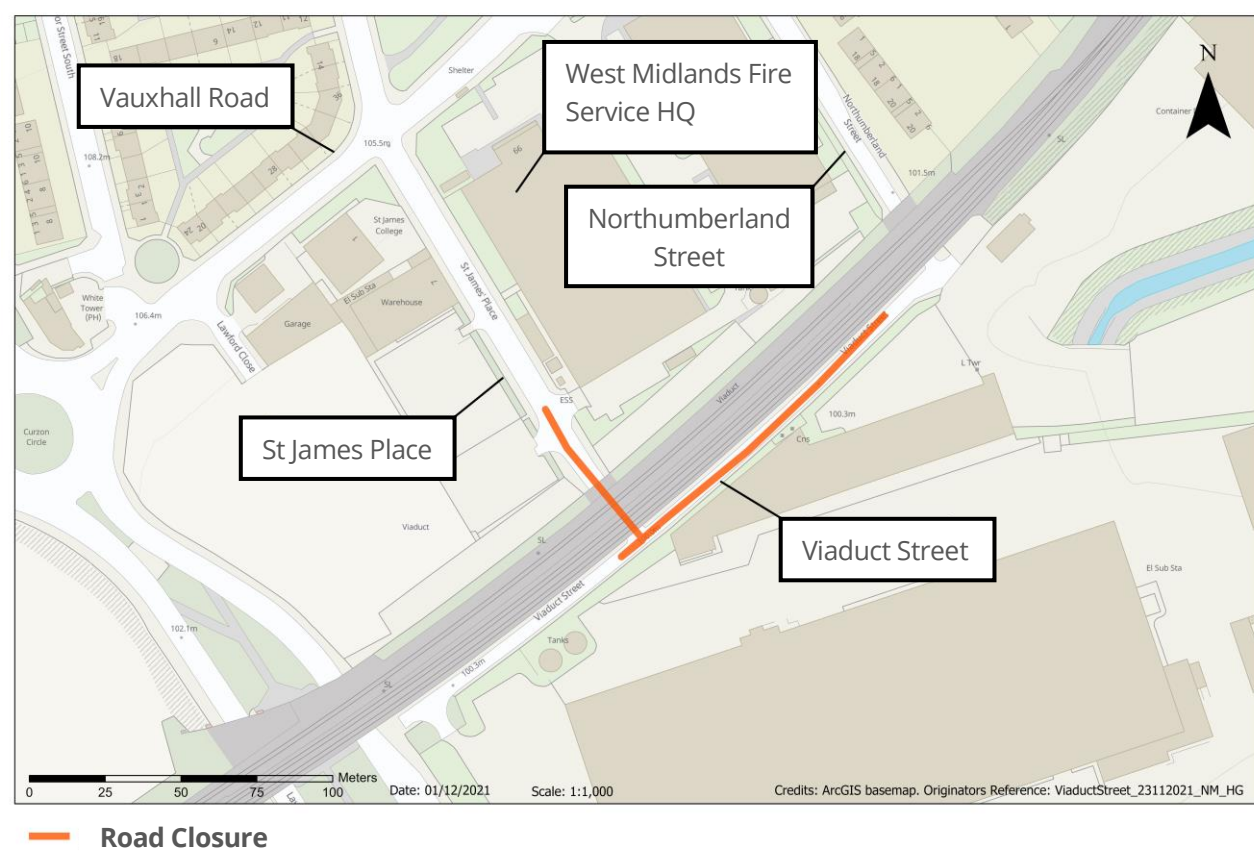
