High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

BBV will be undertaking Ground Investigations (GI) along Crackley Lane. GI is the examination and study of the soil, rocks, and groundwater below the surface. Several methods are used to obtain samples and to monitor and test them. For example, boreholes may be dug by hand around utility pipelines or by using a rig in more open areas. GI may also require the digging of a trial pit or trench. Ground data from GI will ensure that the contractors designing and building the main works can do so safely, economically, and efficiently. The information will also reduce the risk of encountering unexpected ground conditions during construction.

When these works will take place

Crackley Lane will be closed from **4 January 2022** to **6 January 2022**, between 8am and 6pm. Our workforce may be on site an hour before and an hour after those times to set up and secure our equipment. A fully signed diversion will be in place during this time.

HS2 during the Coronavirus pandemic
