High Speed Two (HS2) is the new high speed railway for Britain. Working on behalf of HS2 Ltd, Balfour Beatty is carrying out surveys and investigating ground conditions along the Phase 2a route.

What we are doing

We're carrying out ground investigation work to help us better understand the ground conditions along the route. This will help to inform the detailed design of the railway. To do this, we will use techniques including the drilling of boreholes and trial pits. We will be carrying out survey works on land in Madeley off Netherset Hey Lane. To carry out the work, we will use some heavy goods vehicles as well as light goods vehicles, such as tractors and telehandlers.

Covid-19

We are continually reviewing the works on our construction sites in line with the Government and Public Heath England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

How we will reduce disruption

We will keep construction traffic to a minimum, wherever possible. To reduce impact on your journeys, we will avoid travelling at peak times during the day. We will also keep our sites secure at all times.
