



Notice of break from highway update, Station Road

High Speed Two (HS2) is the new high speed railway for Britain. We continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. What are we doing?

As part of our continued preparatory works, it is necessary to create a break from highway on Station Road.

These works will require a full road closure from the crossroads with Quainton Road and Fiddlers Field to just east of the Railway Centre. A full signed diversion will be in place for the duration of the closure. These works are expected to take approximately four weeks.

To reduce disruption as much as possible the road closure will only be in operation during our core working hours

When will these works take place?

A full road closure will be in place from, 8.00am to 6.00pm, commencing Tuesday 17 January to late February.

Timings of work may vary due to weather and ground conditions, but we intend to work to open the roads to reduce disruption and complete the break from highway as soon as practicable.

Works will commence Tuesday 17 January 2022

Normal working hours:

Monday to Friday

8.00am – 6.00pm

Saturdays

8.00am – 1.00pm

Our contractors may be on site for one hour's start-up and shutdown either side of these times.

What to expect

Varied activities with both quiet and busier periods.

Road closure and some additional traffic.

Noise from plant and equipment used for the works.

What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

Take care to respect the community.

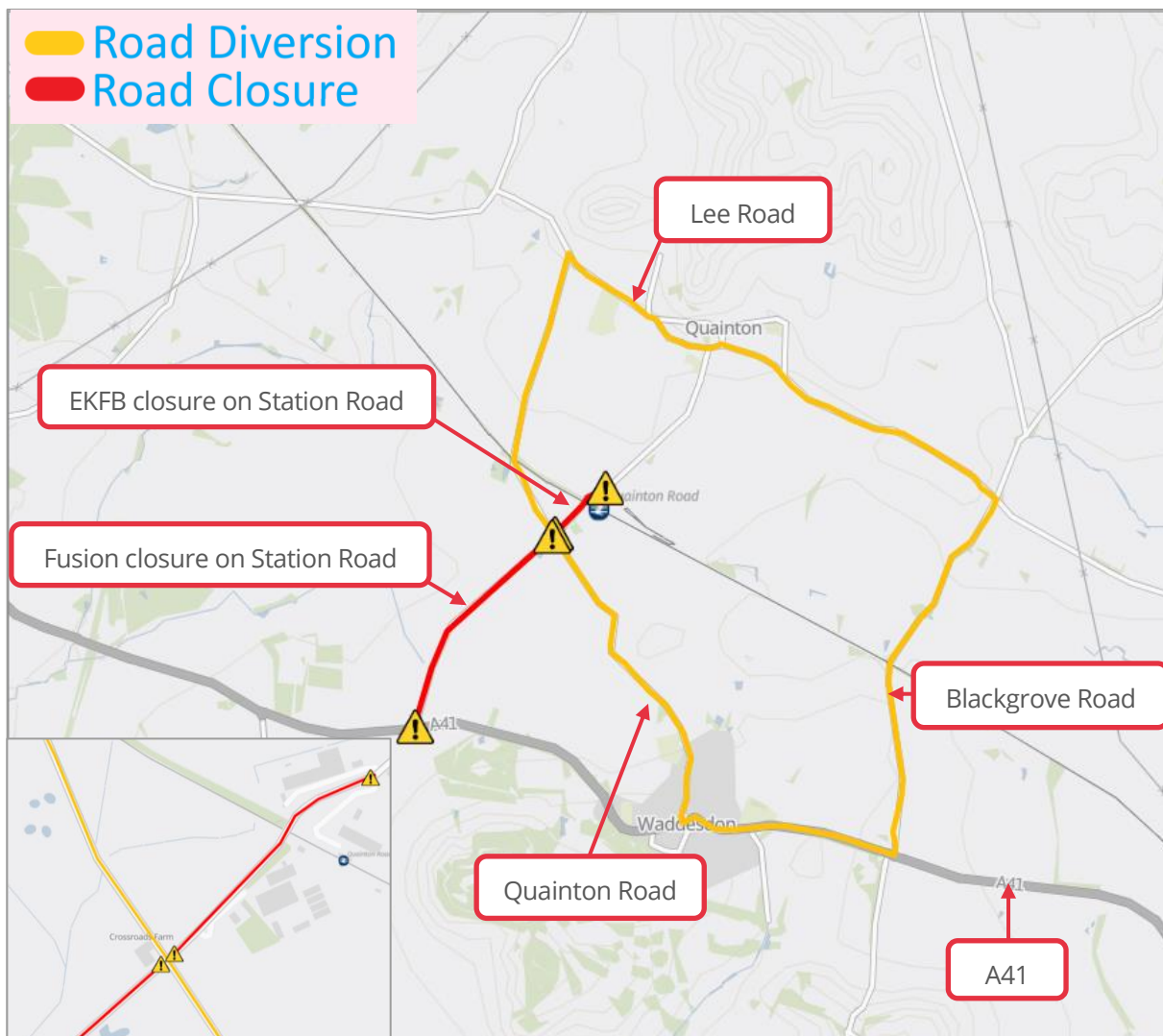


Why are you doing these works?

We need to create this break from highway to allow for our construction vehicles to access from our internal access road from one side of Station Road to the other. Our works in the preparation around construction it will involve locating utilities below ground and installing concrete protection slabs to protect the road and the utilities underneath it. We will also be carrying out earthworks activities and constructing our internal haul and access roads in the area.

Where will the works take place?
