



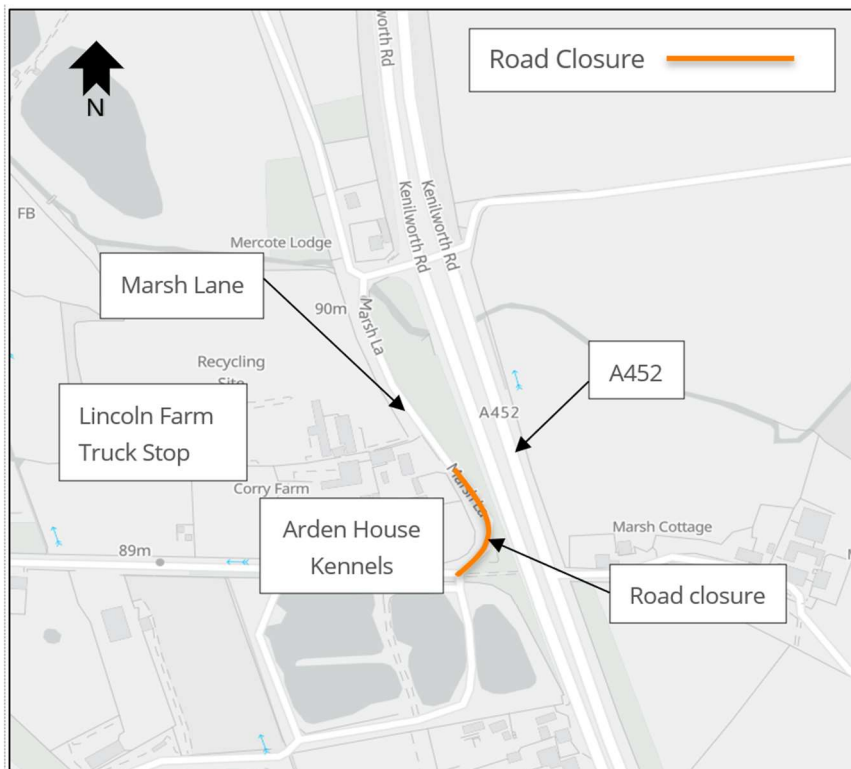
Notice of road closure – Marsh Lane, Balsall Common

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be completing

From Monday 24 January 2022 to Friday 28 January 2022, we will be carrying out trial hole excavations to locate buried utility services in land adjacent to Marsh Lane off the A452 Kenilworth Road. To carry out these works safely, we need to install a closure on Marsh Lane to accommodate the machinery involved. The lane closure will be operational from 09.30am to 3.30pm. The closure will be manned by our traffic management crew to allow access for the residents along Marsh Lane and to escort pedestrians through the closure.

- On Monday 24 January 2022 to Friday 28 January 2022
- Marsh Lane closure will be in place from 09.30am to 3.30pm
- Our workforce may be on site 1 hour before and 1 hour after, to set up and secure our equipment

- Vacuum excavator, traffic management and welfare facilities.
- Low levels of noise from the work we are completing.
