



## Notice of temporary closures of M105 footpath

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

### The work we will be completing

We will be completing utility diversions in areas near the M105 public right of way that links the A452 and the A446, near Melbicks Garden Centre.

For us to complete these works safely, we will install two closures to the footpath in January 2022. Our works will firstly take place from Wednesday 5 January 2022 until Friday 7 January 2022. Following this, our second closure will be in place from Wednesday 19 January 2022 until Friday 21 January 2022. **The location of the footpath closure is shown overleaf.** Our working hours are 8.00am until 6.00pm, Monday to Friday.

### COVID-19

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

- Second closure to be in place from Wednesday 19 January until Friday 21 January

- Slight increase in journey time through the works

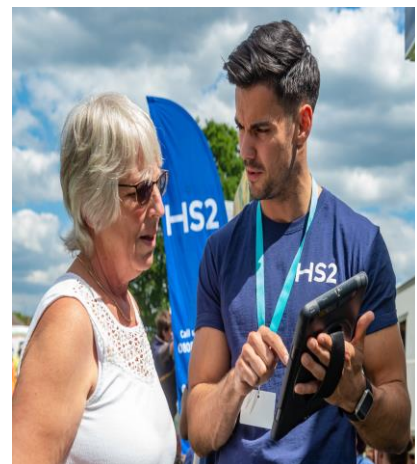
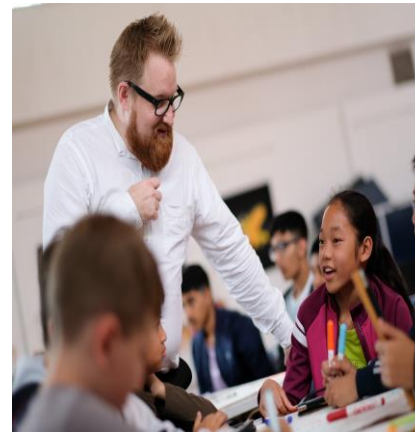
## About our Community and Business Funds
