Notification of traffic management on the B4114

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

We previously notified that we would be undertaking trial hole works on the B4114 near Coleshill Hall Farm from Monday 6 December until Friday 10 December. Due to unforeseen circumstances these works will now take place a week later than planned, from Monday 13 December until Friday 17 September. To carry out these works safely, we will install three-way traffic lights on these dates. Our working hours will be 9.30am until 3.30pm.

HS2 during the COVID-19 pandemic

We are continually reviewing the works on our construction sites in line with the Government and Public Heath England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. - Our workforce may be on site 1 hour before and after to set up and take down equipment


