High Speed Two (HS2) is the new high speed railway for Britain.

We are following Government and Public Health England (PHE) advice on working safely during the pandemic. What we are doing

We wrote to you in September 2021, to let you know that utility works would be starting at the Victoria Retail Park. The main works have now been completed.

From 4 January to 4 February 2022, we will be digging a small trench in the loading bay on the entry to Victoria Retail Park on Victoria Road, Ruislip, in the area shown on the map overleaf. These works will finalise the connection of the various utility supplies into our site.

How the work might affect you

A lane closure and traffic signage will be in place to ensure the work can be carried out safely.

The Old Dairy and Victoria Retail Park will remain open during these works.

Maintain access to your property at all times

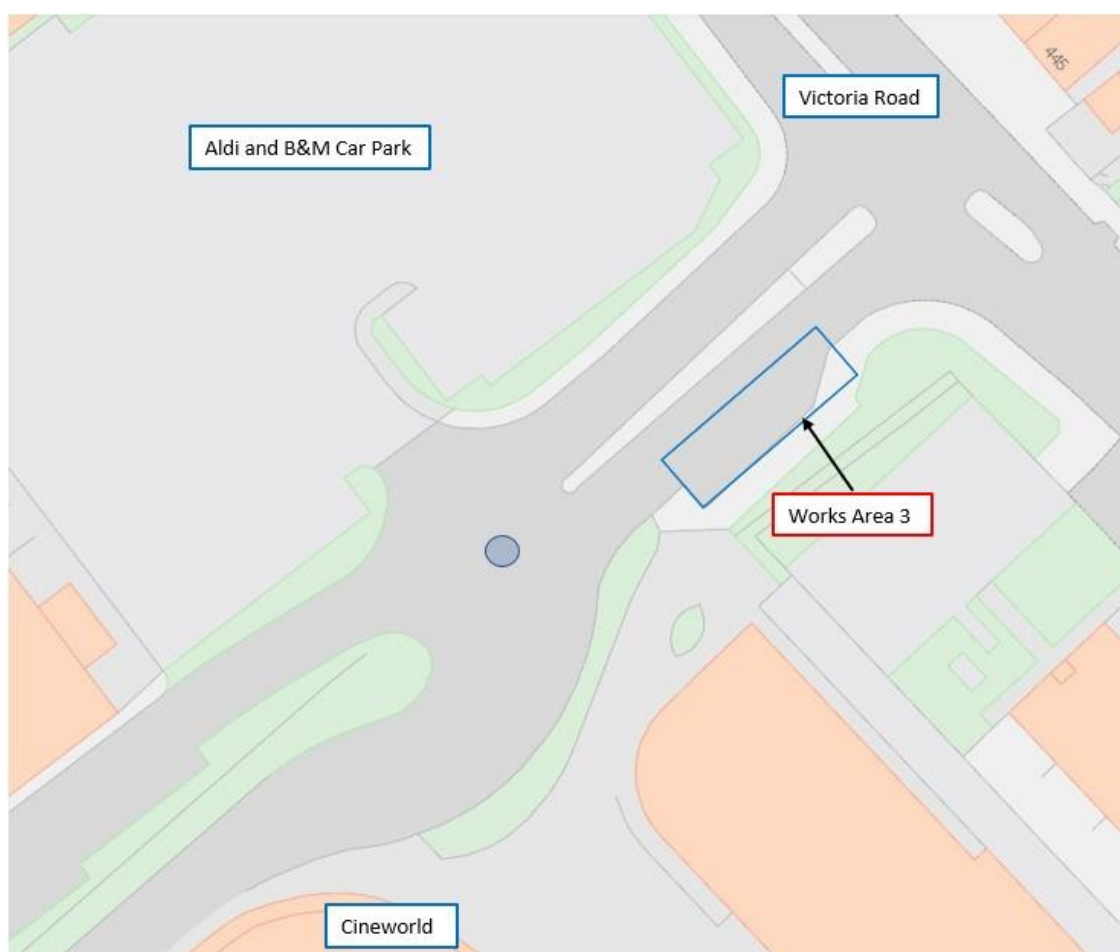
Site will be closed between 24 December 2021 and 3 January 2022 for the festive period. Our site will reopen on 4 January 2022
