Update notice on construction at South Ruislip ventilation shaft site

High Speed Two (HS2) is the new high speed railway for Britain.

We are following Government and Public Health England (PHE) advice on working safely during the pandemic. As we increase face to face engagement, in addition to virtual engagement, we will ensure all events and meetings adhere to the guidelines. What we are doing

We wrote to you in November 2021, to update you on the construction of the ventilation shaft at South Ruislip.

Works at our site will stop from 23 December 2021 to 3 January 2022 for the Christmas period. On 4 January 2022, work will continue as we construct the diaphragm wall for the shaft and excavate to 35 metres below ground level.

From 4 January 2022 to 4 June 2022, we will be excavating and concreting Monday to Friday 24 hours a day and Saturdays 8am to 8pm.

You may experience a period of increased construction noise during this period. Noise and vibration monitoring will be in place throughout these works. We will use water sprays to reduce dust generated by construction activities.

Site lighting over-night will be facing away from residential properties

Noise and vibration monitored regularly

Site will be closed between 24 December 2021 and 3 January 2022 for the festive period. Our site will reopen on 4 January 2022
