## Notice of Access ramp construction work at Mandeville Road

High Speed Two (HS2) is the new high speed railway for Britain.

We are following Government and Public Health England (PHE) advice on working safely during the pandemic. As we increase face to face engagement, in addition to virtual engagement, we will ensure all events and meetings adhere to the guidelines. #### What we are doing

From 31 January to 13 May 2022, we will be constructing the access ramp and lower piling platform at the foot of the railway embankment in preparation for excavation of the vent shafts in the area shown on the map overleaf.

We will be excavating the area behind the sheet piles and creating an access ramp from our site entrance down to the foot of the embankment. Once this ramp is in place, we will construct the lower piling platform.

We will use one excavator, a bulldozer and a roller to compact the ground.

#### **Duration of works**

From 31 January to 13 May 2022

Mon, Wed, Fri - 8am to 6pm

Tues, Thurs - 8am to 8.30pm for deliveries only Sat - 8am to 1pm

We may be on site for an hour before the start and/or end of each shift

#### What to expect

Construction of the access ramp using an excavator. There will be an increase in lorry movements on site as we take away the soil we have excavated. Extended hours twice per week to receive deliveries

#### What we will do

Noise and vibration monitoring will be in place throughout these works We will use water sprays to reduce dust generated by construction activities

#### How these works might affect you

You may experience increased construction noise during this period. Noise and vibration monitoring will be in place throughout these works. Lorry movements in and out of site will increase as we take away the soil we have removed from the embankment.

We will use water sprays to reduce dust generated by construction activities.

We would like to apologise in advance for the disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way. We will ensure that disruption is kept to a minimum.
