High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. As we increase face to face engagement, in addition to virtual engagement, we will ensure all events and meetings adhere to the guidelines. What are we doing?

As our preparatory and enabling works continue, we need to safely access the construction area next to the A361, Byfield Road, north of Chipping Warden. This will require the construction of a temporary access junction on the east side of the Byfield Road.

In order to complete these works, we will need to introduce traffic management in the form of temporary two-way traffic lights for approximately six weeks. To complete these works within this time frame, some additional weekend work may take place.

These traffic lights may be in operation for 24 hours a day during our works.

When will these works take place?

The traffic management on the A361 Byfield Road will be in place from Monday 24 January for approximately six weeks.

We will work to reopen the roads as soon as possible. We would advise allowing more time to complete your journey during this time.

Works will take place between 8am and 6pm – Monday to Friday. Some additional weekend work may also take place under traffic management as required.
