Notice of temporary road closure and footpath diversion update, Banbury Lane, Lower Thorpe Mandeville

High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. As we increase face to face engagement, in addition to virtual engagement, we will ensure all events and meetings adhere to the guidelines. What are we doing?

Following on from trial hole survey work which took place in December 2021, we will close Banbury Lane for approximately four weeks to complete our highway crossing. To reduce disruption in the local area, both EKFB and Fusion will be carrying out work during this closure. Fusion, will be using this closure to complete their programme of bat and ecology mitigation.

In the area where our internal access road crosses Banbury Lane, we will create a strengthened surface using concrete, to ensure that we protect the road and any utilities underneath.

The site access road will reduce HS2 traffic on local highways by providing an internal route from Greatworth Green Tunnel Compound to our construction areas between Lower Thorpe Mandeville and Edgcote.

A public right of way, footpath BB11, from Magpie Farm to Lower Thorpe Mandeville, will be temporarily diverted to a new entry / exit point onto Banbury Lane. This is to avoid footpath users entering our construction area.

When will these works take place?

Banbury Lane will be fully closed, 24 hours a day, from Monday 7 March 2022, with a diversion in place for approximately 4 weeks. This is the maximum duration of the closure. We will endeavour to open the road earlier if possible, depending on the progress and extent of reinforcement work required.

The short diversion of footpath BB11 will last for a period of approximately 4 years.

Duration of works

Works will commence Monday 7 March 2022 and last approximately 4 weeks.

Temporary footpath diversion until approximately 2026.

Normal working hours:

Monday to Friday

8.00am - 6.00pm

Saturdays

8.00am - 1.00pm

Our contractors may be on site for one hour's start-up and shutdown either side of these times.

What to expect

Varied activities with both quiet and busier periods. 24-hour road closures and some additional traffic.

Noise from plant and equipment used for the works

Footpath closures and diversions.

What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

Where will the works take place?

The map below, shows the closure on the Banbury Lane and local diversion. The diversion will be in place for approximately four weeks commencing, Monday 7 March. We will endeavour to open the road earlier if possible, depending on the progress and extent of reinforcement work required.

A public right of way, footpath BB11, from Magpie Farm to Lower Thorpe Mandeville, is located close to this closure area and it will be diverted to a new exit further north along Banbury Lane. A map of this footpath diversion is available on the following page. Footpath users who exit the footpath onto Banbury Lane will be able to continue north in the Culworth direction. However, there will be no access possible through the Banbury Lane closure area.



Temporary diversion of footpath BB11 near Banbury Lane

The map below, shows the new entry / exit point for footpath BB11 onto Banbury Lane, a short distance north of the footpath's existing location. This is to avoid footpath users entering our construction area.

The diversion will remain in place for approximately 4 years.
