High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. As we increase face to face engagement, in addition to virtual engagement, we will ensure all events and meetings adhere to the guidelines. What are we doing?

We will be working on our bailey bridge, the crossing for the access and haul road over the A4421, near Newton Purcell. We will be carrying out masonry works on the bridge abutments.

As this work will be taking place directly above the carriageway, for safety reasons, we will introduce a lane closure and temporary traffic management, in the form of two-way traffic lights, on the A4421.

When will these works take place?

The A4421 will have a lane closure and temporary traffic management either side of the bridge, from 8.00am to 5.00pm, Wednesday 19 January to Tuesday 1 February.

We will work to open the roads to reduce disruption as soon as possible.

Temporary lane closures and traffic management.

Noise from plant and equipment used for the works.

What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

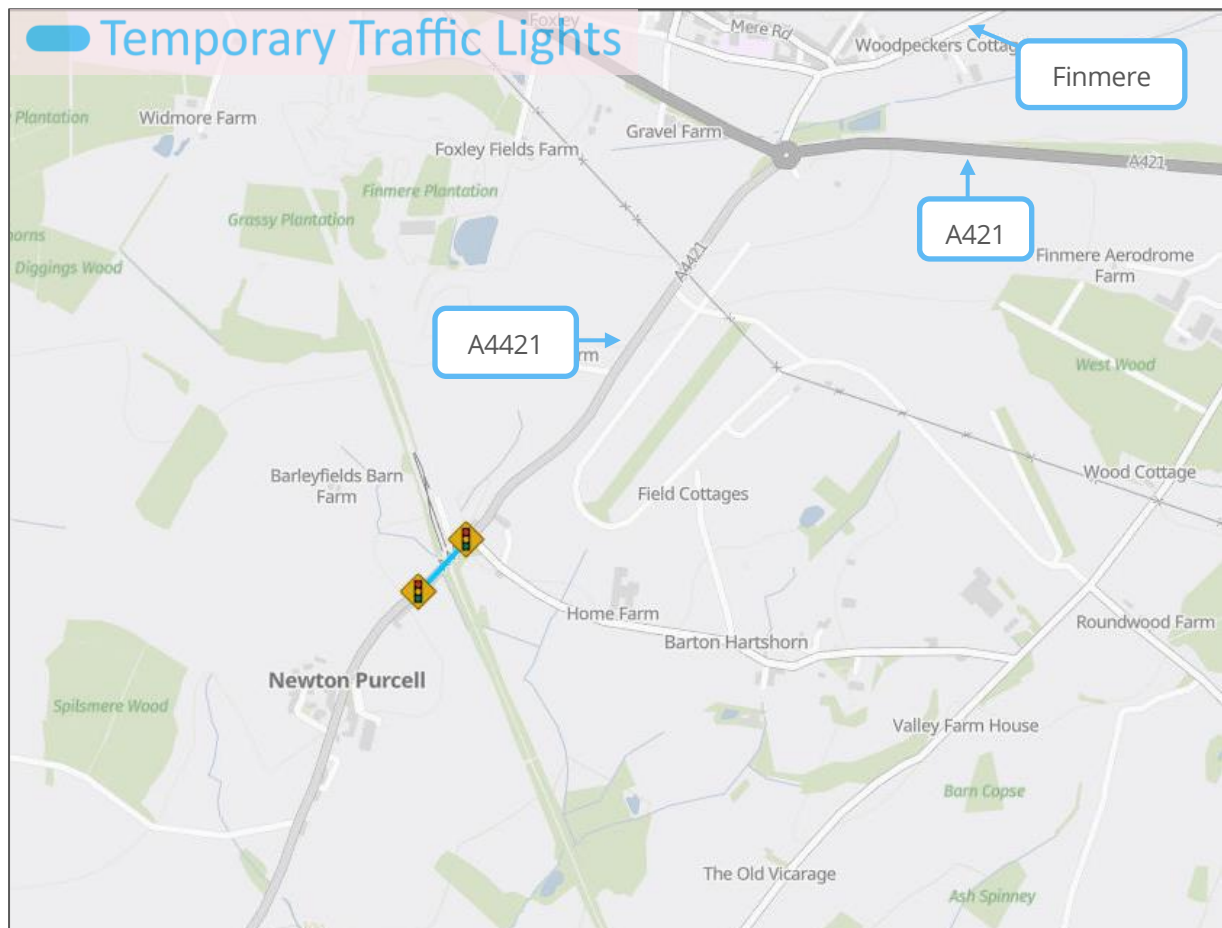
