



## Completion of pipeline diversion works near Swynnerton Road, Stafford

High Speed Two (HS2) is the new high speed railway for Britain. To allow for the construction of the new railway and to continue to ensure a safe and reliable gas supply, Cadent has been working to move an underground gas pipeline near the A51, north-east of Swynnerton. Main works to move the pipeline began in early April 2022 and finished in September 2022.

### What are we doing?

Cadent has now finished moving the pipeline and has successfully carried out routine testing on the relocated pipeline. Cadent is now in the final stages of reinstating its working area, to replace topsoil and vegetation that had to be removed to carry out the diversion.

All Cadent work at this site will be complete by the end of September 2022.

We would like to thank local residents for their continued patience throughout the duration of Cadent's work.

### How will this affect you?

Other works being carried out by HS2 near this site are continuing.

Cadent's temporary works compound and site access off Tittensor Road will remain as they will be used by other HS2 works in the future.

We will keep people up to date as other HS2 works in the area progress.

### COVID-19

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance.

The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

- Inform people in advance of any changes

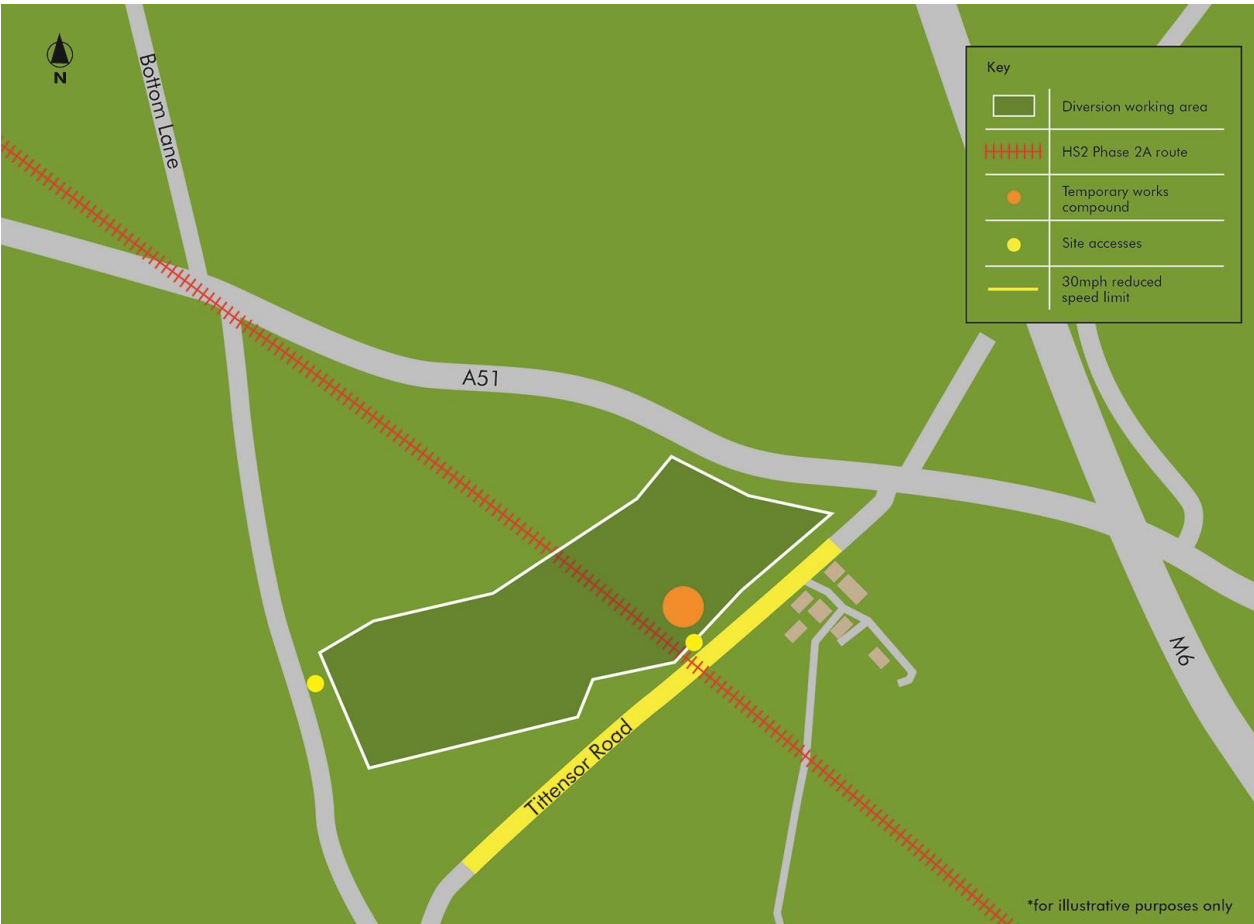
