High Speed Two (HS2) is the new high speed railway for Britain. Working on behalf of HS2 Ltd, Kier is carrying out surveys and investigating ground conditions along the Phase 2a route.

What we are doing

We will be carrying out ground penetrating surveys to help us identify the location of buried utility services, such as gas, electric or water. These surveys are non-intrusive, we will use a machine that transmits an electromagnetic pulse into the ground. These pulses reflect off features in the ground, allowing us to collect data and to understand the depth of the buried utility services.

Along with ground penetrating surveys, we will carry out several other surveys. For the safety of both our workforce and motorists, we will have to close Bottom Lane and Tittensor Road.

When the work will take place

Work will take place from **Monday 31 January** to **Friday 18 February 2022** excluding weekends. Please note that all our planned roadworks may be subject to change due to weather conditions or unforeseen circumstances. We will notify you in advance of any changes.

We are working in line with Government and Public Health England (PHE) advice on working safely during the pandemic. For all events and engagement, we will carry out a risk assessment and put in place control measures to manage the risk of Covid-19 to the public and our staff. How this will affect your journey

On **Monday 31 January** to **Friday 18 February** (excluding weekends) from **9am to 5pm** we need to install temporary traffic lights. These will be located on A51 and A519 Newcastle Road and will differ each day as we move along the carriageway. During these times, journeys make take longer than usual.

On **Wednesday 2 February** to **Friday 5 February** (excluding weekends) from **9am to 5pm** we will need to close Bottom Lane and Tittensor Road. During the road closures, we will put a signed diversion route in place. We will not install traffic lights along the diversion route when in use, but you may notice some additional traffic. Please allow additional time for your journeys during this time.

During the closures, we will maintain access for properties and business in the closure.

About our Community and Business Funds

Two funds are now open for applications from local communities and businesses affected by the construction of HS2. They are the Community and Environment Fund (CEF) and the Business and Local Economy Fund (BLEF). £5 million has been allocated to the funds for phase 2a of the railway.

The CEF is designed to give communities the opportunity to share in the benefits of HS2. It is an allocated fund that communities are able to apply for, to help to support local projects that aim to improve their local area.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
