High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

We will be cleaning out drainage located at the roadside on the A4097 Kingsbury Road. To complete these works safely we will install lane closures with temporary traffic lights on the A4097 Kingsbury Road.

When these works will take place

These works will take place from Monday 14 February to Friday 18 February. And we will have temporary traffic lights and rolling lane closures in place from 9.30am to 3.30pm.

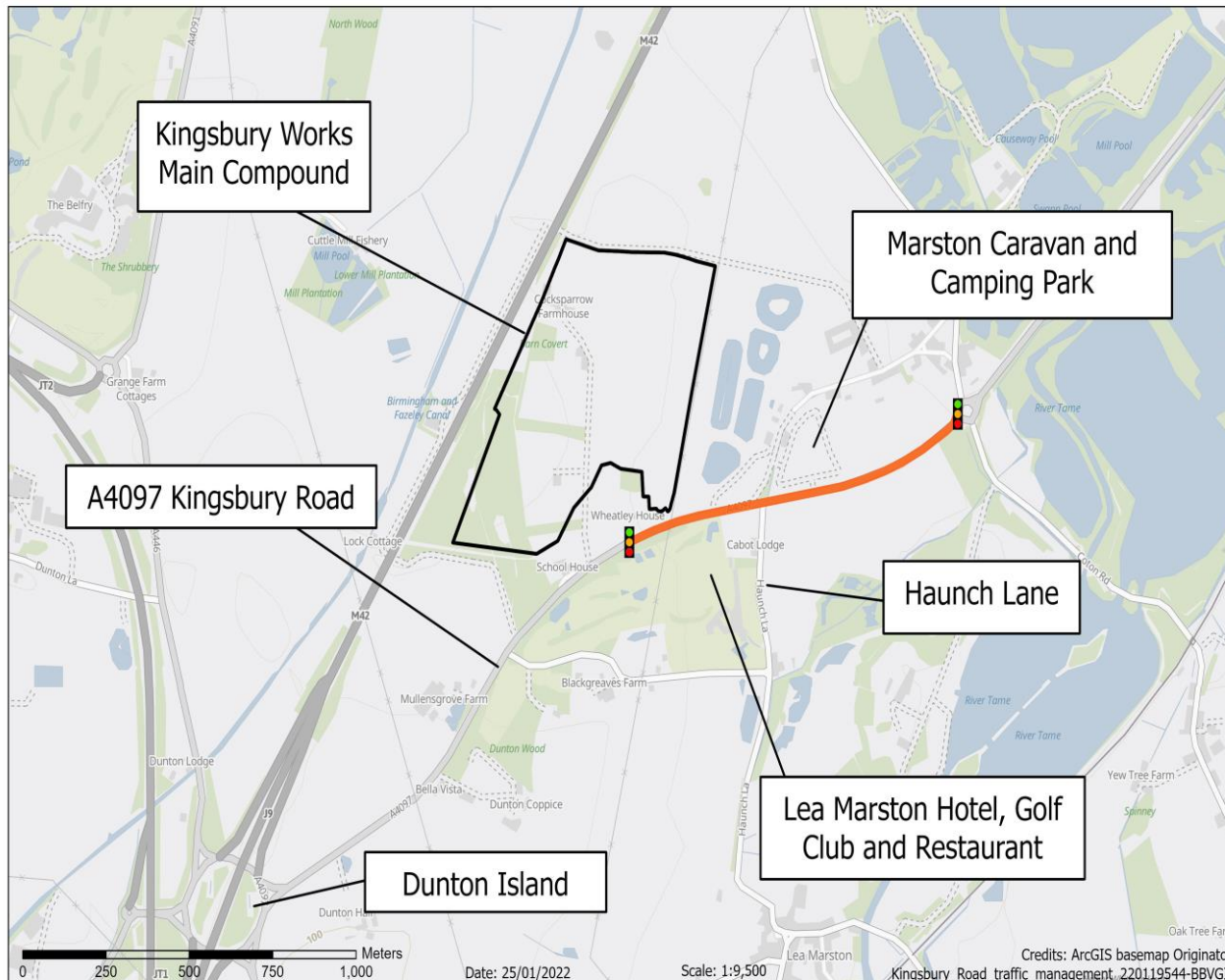
