High Speed Two (HS2) is the new high speed railway for Britain. Working on behalf of HS2 Ltd, Balfour Beatty is carrying out surveys and investigating ground conditions along the Phase 2a route.

What we are doing

We're carrying out ground investigation work to help us better understand the ground conditions along the route. This will help to inform the detailed design of the railway. To do this, we will use techniques including the drilling of boreholes and trial pits. We will be carrying out survey works on land off A53 between 'The Old Rectory' and 'The Hill'. To carry out the work, we will use some heavy goods vehicles as well as light goods vehicles, such as tractors and telehandlers.

Duration of works

- The works are due to start in early March 2022 and are expected to last until late March 2022
- Our working hours will be 8am to 6pm, Monday to Friday

What to expect

- Slightly more traffic than usual on A53 for the duration of works
- Temporary traffic lights on A53 on 9 to 11 March and 21 & 22 March 2022
- Possible visual and sound impact on your property

What we will do

- Carry out the work in compliance with the Code of Construction Practice
- Inform you in advance of any changes to the dates and working times
- Keep all sites safe and secure
