High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. As we increase face to face engagement, in addition to virtual engagement, we will ensure all events and meetings adhere to the guidelines. What are we doing?

Following our recent works at the end of 2021 we need to remove the remaining excavated material from site. To complete this activity, we will use a 20-tonne excavator. Due to the current ground condition, it is unsuitable to bring a HGV loaded with excavator directly into the field. We will instead, need to unload and reload the excavator from the HGV trailer onto Banbury Road, next to the access point.

To enable us to do this safely we will have two 15-minute full road closures on

Thursday 13 January 2022 (unload)

Tuesday 18 January 2022 (reload)

The closures will take place during off peak times, between 9am and 3pm.

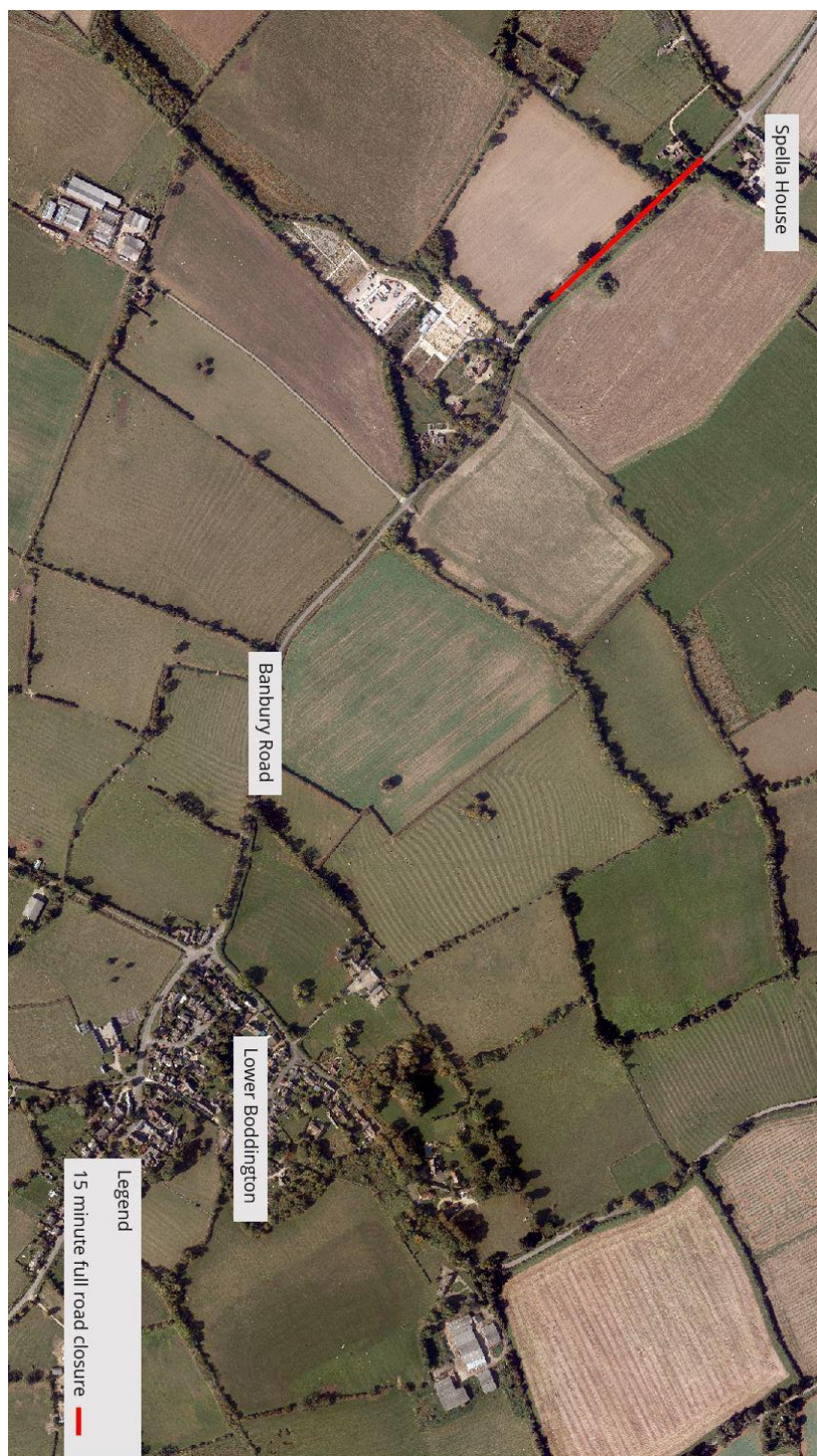
