High Speed Two (HS2) is the new high speed railway for Britain.

# What are we doing?

In January, Western Power Distribution (WPD) need to carry out some ground investigation works, to enable the diversion of our 11,000 volt overhead line to underground cable.

This will involve drilling 3no. boreholes into the ground so we can ascertain the make-up of the soil and rock construction in the area.

These works are anticipated to take 5 days.

# How will this impact you?

There will be minimal impact on the surrounding area. The works will be confined to private land but you will see vehicles & equipment in the field. To access the area we will be using an existing access point from Crackley Lane.

# What to expect


- Limited vehicle movements to and from site.
