## Notice of footpath closure and diversion, TUW/3/2, Turweston

High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. As we increase face to face engagement, in addition to virtual engagement, we will ensure all events and meetings adhere to the guidelines. #### What are we doing?

As our part of our continued preparatory works, we will be temporarily closing and diverting a footpath between Turweston and Westbury.

Soon we will begin excavating and moving earth with large plant and machinery. These works will cross footpath TUW/3/2.

For the safety of pedestrians and our staff, we must fully close footpath TUW/3/2 for the duration of our works. Signage on the footpath will indicate the closure and there will be a local diversion in place.

#### When will these works take place?

Footpath TUW/3/2 will be fully closed with a diversion in place, 24 hours a day, week commencing Monday 31 January 2022, for a period of approximately three years.
