High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. As we increase face to face engagement, in addition to virtual engagement, we will ensure all events and meetings adhere to the guidelines. What are we doing?

Further to our last notification regarding the flooding on Banbury Road near to the junction of Leisure Drive, we have an update below;

We have identified a blocked and potentially damaged drainage pipe crossing underneath Banbury Road. We need to undertake further investigatory work to assess the issue and to plan any drainage improvement works that may be required.

We are currently using a road sweeper to remove the excess water as the flooding returns due to the runoff from adjacent fields.

To ensure a safe working area and passage around the flooded area, we will change the traffic management to three-way traffic lights on Banbury Road and Leisure Drive which will be in place 24/7 until the works are completed, please see location on the map enclosed.
