



## Notice of traffic management- Gilson Road (revised date)

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

### The work we will be completing

Balfour Beatty VINCI (BBV) had previously notified about works being completed to widen the site access on Gilson Road from Monday 24 January until Sunday 6 February. However, due to unforeseen ecology issues these works will be extended by a week until Monday 14 February.

In order for us to carry out these works safely, we have installed temporary two-way traffic lights. The traffic lights will now be in place throughout our works until Monday 14 February, 24 hours a day and pedestrian access will be maintained at all times. If our works are complete prior to this, we will remove the traffic management in place.

Our working hours are 8am until 6pm Monday to Friday and 8am until 1pm on Saturdays. Our workforce may be on site 1 hour before and 1 hour after, to set up and take down equipment.

### HS2 during the COVID-19 pandemic

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

### Duration of works

- Two weeks of temporary traffic lights from 24 January until 6 February 2022 has been extended to 14 February
- Traffic lights will be in place 24 hours a day
- Our working hours are 8am until 6pm Monday – Friday and 8am until 1pm on Saturdays

### What to expect

- Slight increase to traffic on Gilson Road
- Pedestrian access maintained at all times
- Our workforce may be on site 1 hour before and 1 hour after, to set up and take down equipment
