High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

We will be undertaking Ground Penetrating Radar (GPR) surveys on the B4114 near Coleshill Hall Farm, which will help us to understand what is under the surface of the road. For us to complete these works safely, we will implement a three-way traffic light system on the B4114 Birmingham Road. The traffic lights will be in place for five days from Monday 31 January until Friday 4 February. Our working hours will be 9.30am until 3.30pm.

HS2 during the COVID-19 pandemic

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. - GPR surveys on the B4114 Birmingham Road
- Works to be undertaken from 31 January until 4 February

What to expect

- Three-way traffic light system in place on the B4114 Birmingham Road
- Our working hours will be from 9.30am until 3.30pm
- Slight increase to traffic on the B4114 Birmingham Road
- Our workforce may be on site 1 hour before and after to set up and take down equipment

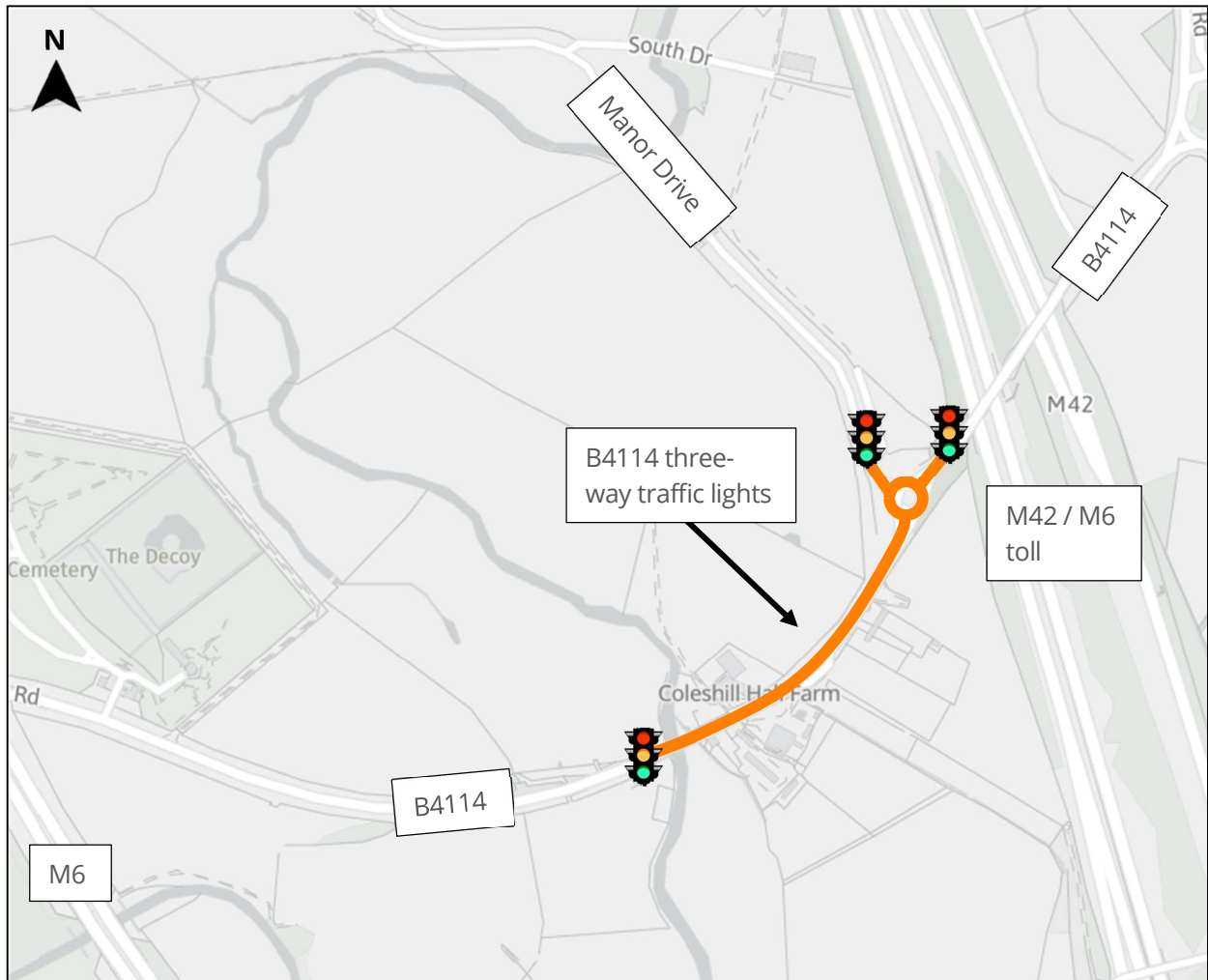
