# Update: Parkway utility works and overnight road closure on Albert Street

High Speed Two (HS2) is the new high speed railway for Britain.

## Parkway utility works extended until 19 January

We previously notified about works to strengthen and divert services beneath Parkway before we begin tunnelling in late 2023.

The trial hole works within the footway near the junction with Gloucester Avenue were due to be completed by 16 January but have been delayed due to unforeseen obstructions in the ground and will now be completed by **19 January** when we will remove the traffic management.

## Installation of monitoring equipment on Parkway – 26 January

On **26 January** we will return to install monitoring equipment within the footway on Parkway, near the junction of Gloucester Avenue outside North Bridge House School. We will only need a partial footway closure for these works.

## Overnight road closure on Albert Street – 26, 27 January and 2 February

We previously notified about overnight surveys of the Thames Water mains on Albert Road at the junction of Parkway. Please follow the link to our previous notification.

We had planned to close the road **overnight from 7pm to 6am** on 19 and 20 January but this is now postponed to **26 and 27 January**.

Traffic will be diverted down Arlington Road and Delancey Street. We will re-open the road during the day

The 'no entry' restriction onto Albert Street from Delancey Street will be lifted during the hours of the closure to allow vehicles to drive in both directions to access local properties and businesses.

We will use the results of the visual survey to decide if we need to close the road again on **2 February**.
