High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by a joint venture between Laing O'Rourke and Murphy & Sons known as LM.

We will be carrying out carriageway works on Park Street.

As we undertake utility diversions in preparation for the construction of HS2's Curzon Street Station and the railway, we'll be working on Park Street. To carry out the works safely, we need to manage traffic in this local area, this will include lane closures and pedestrian management. As part of these works, we will be installing directional road signage, replacing road markings and constructing new pedestrian crossing points.

Access to frontages will be maintained. No traffic diversions are required for this work and signs will indicate pedestrian routes.

We may be on site up to an hour before or after our working hours.
